RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE RENEWAL PERSONAL SERVICES CONTRACT WITH COMMUNITY RECOVERY RESOURCES (CoRR) FOR ADULT DRUG COURT SERVICES (RESOLUTION 16-439)


WHEREAS, per Resolution 16-439, the Board of Supervisors approved the Fiscal Year 2016/17 renewal Contract with Community Recovery Resources (CoRR) for the provision of substance abuse treatment services to Adult Drug Court Participants; and

WHEREAS, Adult Drug Court in Nevada County provides direct court supervision, regular drug testing, substance abuse treatment services (both residential and outpatient) and treatment activities, and these services are provided through collaboration between the Probation Department, the Court, the Public Defender's Office, the District Attorney's Office, the Behavioral Health Department, and contracted providers; and

WHEREAS, the parties desire to amend their Agreement to increase the maximum contract price due to an unanticipated increase in services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County and Community Recovery Resources (CoRR) pertaining to increasing the contract maximum price from \$139,251 to \$164,251 (an increase of \$25,000) for the provision of substance abuse treatment services to Adult Drug Court Participants, for the contract term of July 1, 2016 through June 30, 2017, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

AMENDMENT #1 TO THE CONTRACT WITH COMMUNITY RECOVERY RESOURCES (CoRR) (RES 16-439)

THIS AMENDMENT is dated this 23rd day of May 2017 by and between COMMUNITY RECOVERY RESOURCES (CoRR) hereinafter referred to as "CONTRACTOR" and COUNTY OF NEVADA, hereinafter referred to as "COUNTY". Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract as approved per Resolution No. 16-439.

WHEREAS, the CONTRACTOR provides alcohol/drug treatment services to Adult Drug Court clients for the County's Behavioral Health Department for the contract term of July 1, 2016 through June 30, 2017; and

WHEREAS, the parties desire to amend their Agreement to 1) increase the maximum contract price from \$139,251 to \$164,251 (an increase of \$25,000) due to an unanticipated increase in services and 2) amend Exhibit "B" to reflect this increase in maximum obligation.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That Amendment #1 shall be effective as of May 23, 2017.
- 2. That Section (§2) Maximum Contract Price, shall be changed to the following: \$164,251.
- 3. That Exhibit "B", Schedule of Charges and Payments, shall be revised to the amended Exhibit "B" as attached hereto and incorporated herein.
- That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS COMMUNITY RECOVERY RESOURCES

The maximum amount payable for satisfactory performance of services in accordance with Exhibit "A" under this contract shall not exceed \$164,251 for Fiscal Year 2016/17.

Reimbursement for Drug Court Services shall be based on the following:

1. The Contractor's usual and customary charge to the general public for the same or similar services.

Monthly invoicing for payment under this Agreement shall be based on funding of last resort. All other sources of funding shall be pursued prior to submission of invoices to the County.

The following fees for services will be maintained for this contract period (July 1, 2016 through June 30, 2017) and Outpatient and Perinatal are established by State's proposed 16/17 Drug Medi-Cal rates.

- Outpatient: \$66.53 for one-on-one individual sessions; \$27.04 group
- **Perinatal**: (MIR) \$105.90 for one-on-one individual sessions; \$81.22 IOT; \$52.11 ODF Group
- Residential: \$99.97 per day (Hope House/Serenity House) / \$80 per day (Auburn Campus Residential)
- **Detoxification:** \$99.97 per day (Hope House/Serenity House) / \$80 per day (Auburn Campus Residential)
- Transitional/Supportive Housing: \$600 per month (\$19.73 daily) for each authorized individual. County shall be billed only for those days the County authorized client was a resident in said program. For stays less than thirty (30) days, rates shall be prorated.
- Provision of nutrition counseling and nutrition monitoring services, food, sundry necessities and household items including bed linens and towels: Contractor shall be reimbursed at an amount not to exceed \$300 per month for each authorized Transitional Housing individual.
- Court Attendance and Consultation \$50/hour.
- Assessments: \$250
- Ancillary Services: Vary; as charged to public. Typical fees are:
- Smoking Cessation Classes: \$25 per session.
- Lifeskills & Literacy: \$25 per session.
- **DUI**: State established fees \$250 to \$1700 depending on required program
- Parenting (Incredible Years or Parent Project) at \$150/person

Contractor shall bill County in arrears for monthly services rendered. Contractor shall submit invoices identifying client(s), services, funding source, and dates of services. Payment to Contractor shall be made after verification of services by County's Behavioral Health Department.

Contractor shall submit quarterly fiscal reports, including detailed list of costs for the prior quarter and cumulatively during the contract period.
