



# RESOLUTION No. 21-492

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AUTHORIZING ENVIRONMENTAL CLEARANCE FOR GUARDRAIL SAFETY AUDIT PROJECT

WHEREAS, the Nevada County Department of Public Works proposes a guardrail upgrade construction project known throughout the design and construction phases as the Guardrail Safety Audit Project; and

WHEREAS, the various guardrail locations designated "U" on Exhibit A require upgrading to bring them up to current design standards; and

WHEREAS, the location designated "N" is a new guardrail segment that is needed at Magnolia Road / Kingston Lane; and

WHEREAS, Highway Safety Improvement Program (HSIP) funds are available for this project; and

WHEREAS, under Sections 15301(c) and 15301(f) of the CEQA Guidelines, Class 1 projects consisting of the repair or minor alteration of existing structures or facilities with no, or negligible expansion of use, and the addition of safety devices for use in conjunction with existing facilities are categorically exempt from the provisions of the California Environmental Quality Act.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, authorizes the Director of the Nevada County Department of Public Works to file a Notice of Exemption with the Nevada County Clerk-Recorder's Office for the Guardrail Safety Audit Project.
