WHEREAS, the County of Nevada entered into an agreement with J.W. Bamford, Inc. by Resolution 22-551 for the Hazard Tree Removal Project for a contract totaling \$184,942.48 plus a 10% contingency of \$18,494.25, for a total Project budget of \$203,436.73; and

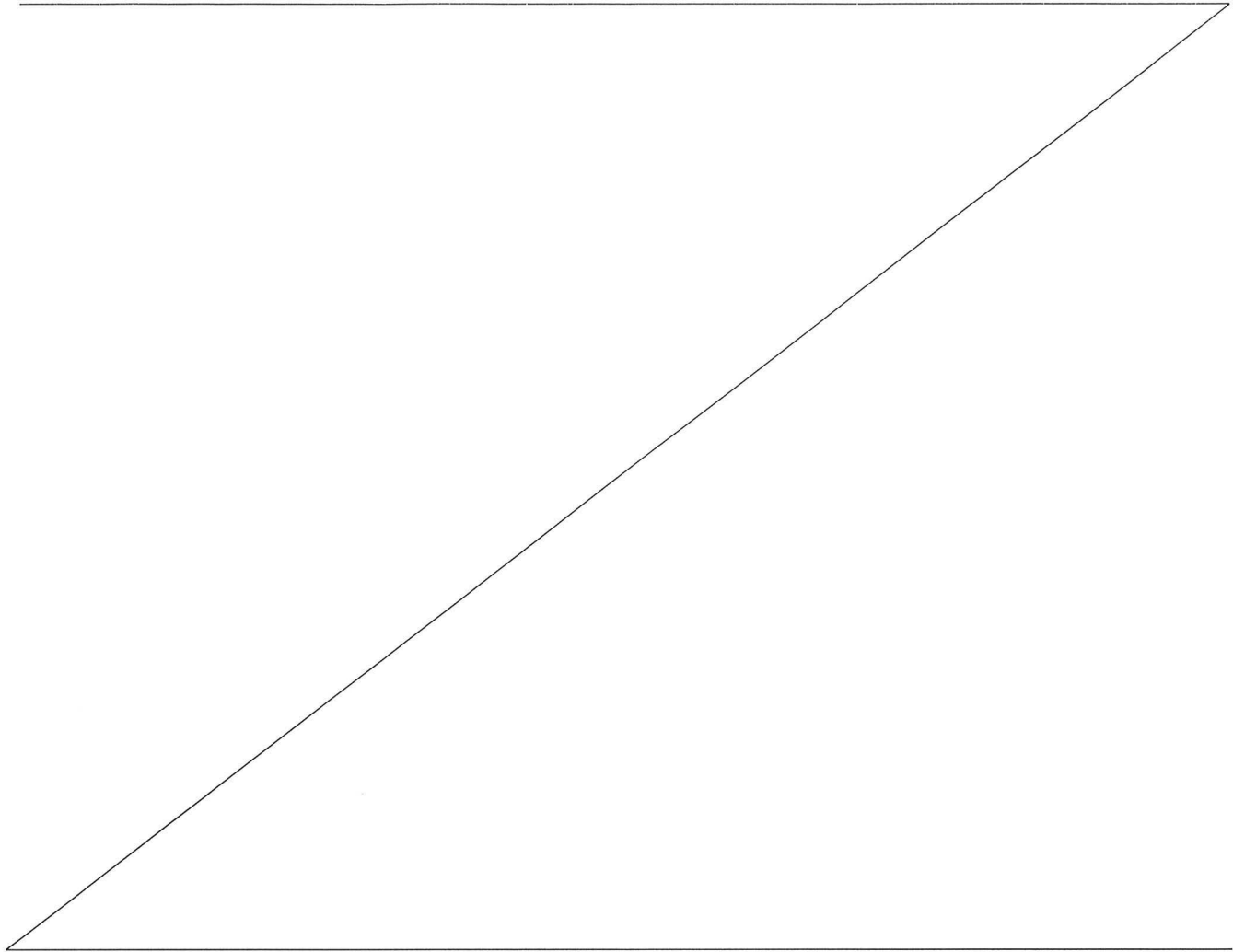

WHEREAS, the Project improvements were completed to the satisfaction of the Nevada County Department of Public Works on August 1, 2023, with contract costs totaling \$385,852.74.

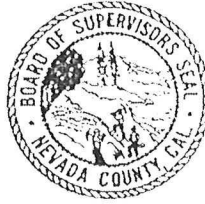
