



RESOLUTION No. 23-450

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION SETTING THE AD VALOREM TAX RATE AND ESTABLISHING THE LEVY RATES FOR THE GENERAL OBLIGATION BONDS AND/OR OTHER VOTER APPROVED DEBT FOR FISCAL YEAR 2023/24

WHEREAS, California Government Code Section 29100 specifies that the Board of Supervisors shall annually adopt by resolution a property tax rate, not to exceed the 1% limitation specified in Article XIII A of the Constitution and Sections 93 and 100 of the Revenue and Taxation Code, of the full taxable value and set the allowances for delinquencies; and

WHEREAS, California Revenue and Taxation Code 93(a) and 100(b) authorize the levy of additional taxes to make annual payments for general obligation bonds and/or other indebtedness approved by the voters.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, as follows:

1. A tax rate of 1% of the full taxable value on the secured and unsecured roll is hereby levied for Fiscal Year 2023/24.
2. The County Auditor shall levy general obligation bonds and/or other indebtedness tax rates for the various school districts and special districts, as set forth in Exhibit A.
3. A delinquency allowance of 5% shall apply on the calculation of general obligation bonds and/or other indebtedness required to be set by the Auditor's office.


