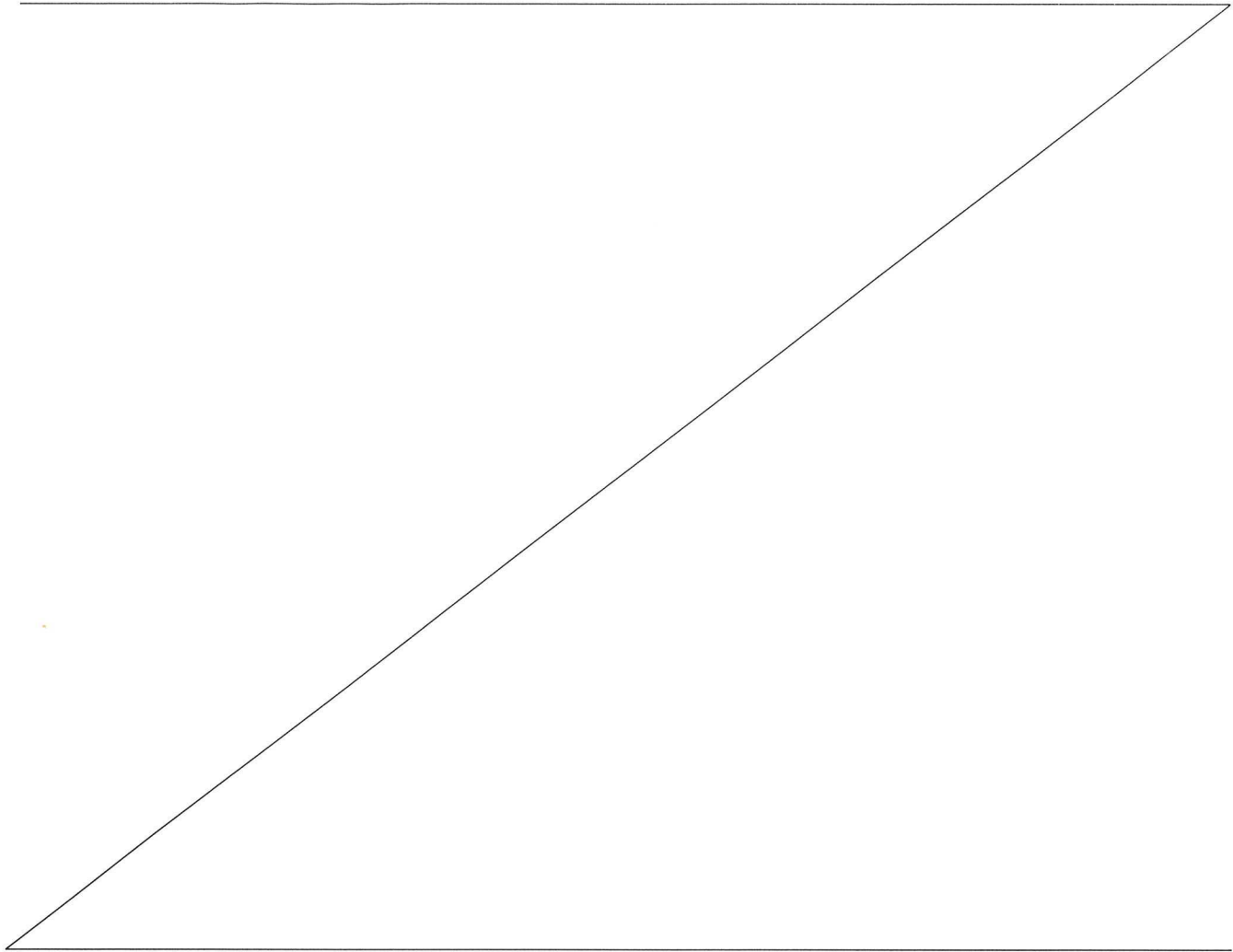
WHEREAS, the County of Nevada entered into an agreement with Baldwin Contracting Company, Inc., dba Knife River Construction by Resolution 23-212 for the 2023 Road Rehabilitation Project for a contract totaling \$1,273,953.24 plus a 10% contingency of \$127,395.32, for a total Project budget of \$1,401,348.56; and

WHEREAS, said contract for the 2023 Road Rehabilitation Project (Project) was completed in accordance with the plans and specifications; and

WHEREAS, the Project improvements were completed to the satisfaction of the Nevada County Department of Public Works on August 8, 2023, with contract costs totaling \$1,354,328.60.

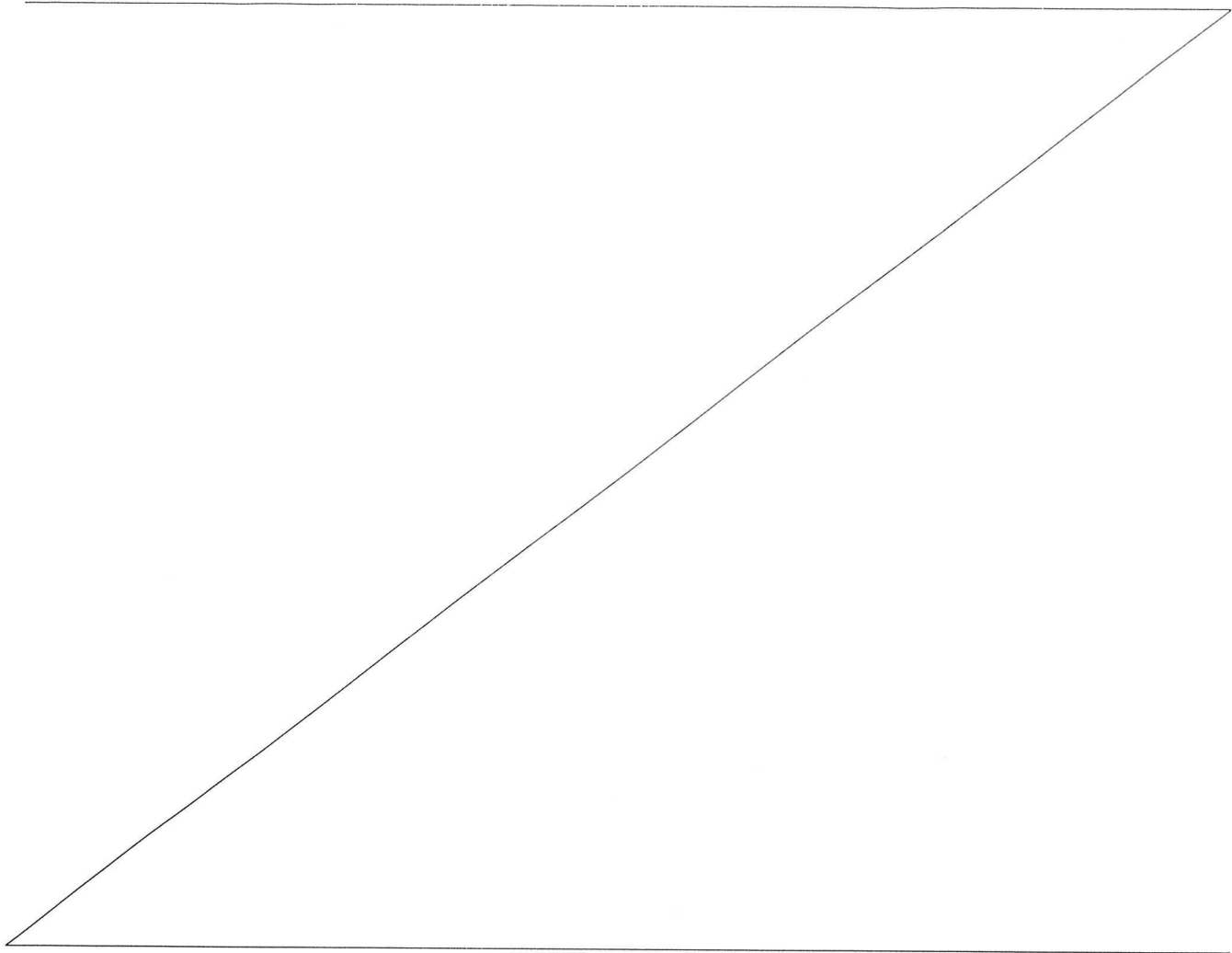

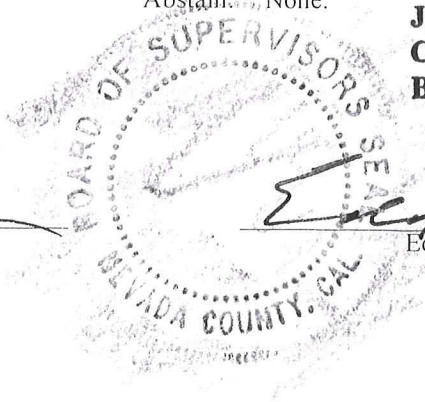
