



# RESOLUTION No. 16-381

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING AMENDMENT NO. 3 TO THE AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PARATRANSIT SERVICES FOR THE PROVISION OF SPECIALIZED PARATRANSIT SERVICES IN WESTERN NEVADA COUNTY

WHEREAS, on May 14, 2013, the Nevada County Board of Supervisors adopted Resolution 13-168, approving a five-year contract with Paratransit Services for provision of specialized Paratransit Services in Western Nevada County that began on July 1, 2013 and will expire on June 30, 2018; and

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution 14-362 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 11, 2015, the Nevada County Board of Supervisors adopted Resolution 15-392 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, the contract agreement contains a provision for an annual increase of the Paratransit Services contract price that includes both a fixed vehicle service hourly rate and a fixed monthly rate on July 1<sup>st</sup> of each contract year equivalent to the increase in the CPI (California Consumer Price Index, California Department of Industrial Relations, Division of Labor Research, All Urban Consumers) for the most recent available twelve month period prior to each scheduled increase in an amount of not less than one percent (1%), with a cap of three percent (3%) annually; and

WHEREAS, the California CPI calculation for the twelve month period of April 2015 through April 2016 reports a 2.2 percent increase; and

WHEREAS, Nevada County and Paratransit Services wish to amend the contract agreement to include an increase of the Paratransit Services' fixed vehicle service hourly rate to \$35.88 and the fixed monthly rate to \$56,692 per the applicable annual CPI effective July 1, 2016 through Fiscal Year 2016/17; and

WHEREAS, Paratransit Services has reviewed its Cyber Liability Insurance coverage and determined that they will increase their coverage based on industry standard and best practice and include this item in current contracts; and

WHEREAS, Paratransit Services will secure the Cyber Liability Insurance coverage and cover the cost associated with this coverage at no expense to Nevada County; and

WHEREAS Nevada County and Paratransit Services wish to amend the contract agreement to include a Cyber Liability Insurance provision; and

WHEREAS, there is sufficient budget available to fund this contract in the Fiscal Year 2016/17 budget code 4281-91003-707-1000 521520.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the attached Amendment to increase the Paratransit Services' fixed vehicle service hourly rate to \$35.88 and the fixed monthly rate to \$56,692 through Fiscal Year 2016/17 and include a Cyber Liability Insurance coverage provision in the contract agreement.
2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Paratransit Services.

AMENDMENT NO. 3

PARATRANSIT SERVICES CONTRACT

THIS AMENDMENT is executed this 26<sup>th</sup> day of July, 2016, by and between PARATRANSIT SERVICES and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract between County of Nevada and Paratransit Services for Provision of Specialized Paratransit Services in western Nevada County, executed on July 1, 2013, by Resolution No. 13-168 and which agreement was subsequently amended on July 22, 2014, by Resolution Number 14-362 and on August 11, 2015, by Resolution Number 15-392.

NOW, THEREFORE, the parties hereto agree as follows:

1. To increase the Paratransit Services' fixed vehicle service hourly rate to \$35.88 and the fixed monthly rate to \$56,692 through Fiscal Year 2016/17 and include a Cyber Liability Insurance coverage provision in the contract agreement.
2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
