## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING PURCHASE OF RADIO COMBINING EQUIPMENT FOR PHASE 2 OF THE NEVADA COUNTY SHERIFF'S OFFICE RADIO INFRASTRUCTURE IMPROVEMENT PROJECT IN THE AMOUNT OF \$35,737.52 INCLUDING SALES TAX, APPROVING THE ASSOCIATED CAPITAL ASSET REQUEST, AND APPROVING THE RELATED BUDGET AMENDMENT (4/5THS AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, the Nevada County Sheriff's Office desires to maintain security and safety for the Public and its Law Enforcement Officers; and

WHEREAS, it is acknowledged that radio communications are a critical component of public safety in both normal and emergency operations; and

WHEREAS, the Sheriff's Office desires to replace and upgrade its current radio systems inclusive of mobile vehicle, handheld, and radio tower systems in a phased approach; and

WHEREAS the Sheriff's Office has obtained Congressionally Directed Funding in the amount of \$4,800,000 towards the cost of this project; and

WHEREAS, on December 13, 2022, via Resolution 22-608, the Board authorized Phase 1 of the Sheriff's Office radio infrastructure improvement project, which consisted of replacing mobile vehicle, and handheld radios along with associated equipment with appropriate Motorola products in the amount of \$1,600,000; and

WHEREAS, on August 6, 2024, via Resolution 24-438 and 24-439, the Board approved two Communications System and Services Agreements with Motorola for the purchase of \$2,479,352 (Phase 2) and \$317,968 (Phase 3) for Motorola equipment and services for the radio infrastructure improvement project and identified this equipment as capital assets of the County of Nevada; and

WHEREAS, on August 6, 2024, via Resolution 24-437, the Board approved joining the State of California Office of Emergency Services (OES) Public Safety Communications (PSC) California Radio Interoperable System (CRIS) whereby Nevada County will lease, at no cost, radio equipment to the State; and

WHEREAS, the Sheriff's Office desires to purchase radio combining equipment for two radio communication sites located in mountainous terrain that will minimize VHF interference and result in better integration with the CRIS system.

THEREFORE, BE IT RESOLVED, that the Nevada County Board of Supervisors, on behalf of the County of Nevada:

- 1) Approves the purchase of the public safety radio equipment and related services in the amount of \$35,737.52 from Telewave.io; and
- 2) Authorizes the Purchasing Agent to encumber the funds, issue a purchase order and sign any documents related to the purchase; and
- 3) Approves the public safety radio equipment as capital assets of the County of Nevada for two future radio communication site locations; and
- 4) Directs the Auditor/Controller to amend the Sheriff's Office FY 24/25 budget as follows:
