RESOLUTION No. 17-179

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO AWARD A CONTRACT FOR THE NEVADA COUNTY HIGH FRICTION SURFACE TREATMENT (HFST) 2017 PROJECT – FEDERAL NO. HSIP-5917 (095), COUNTY CONTRACT NO. 225029 AND AMENDING THE FISCAL YEAR 2016/17 DEPARTMENT OF PUBLIC WORKS ENGINEERING DIVISION BUDGET DISTRICTS I, II, III, IV (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the County of Nevada Board of Supervisors approved an environmental clearance for the placement of a roadway high friction surface treatment on roadways shown on the attached list; and

WHEREAS, bids were opened on February 28, 2017 with the low bid being \$661,000; and;

WHEREAS; The Nevada County Department of Public Works proposes to provide High Friction Surface Treatment (HFST) on various curves with high run off the road vehicle accidents at locations throughout rural Western Nevada County roadways; and

WHEREAS, Highway Safety Improvement Program (HSIP) and State Exchange Funds are available for this project; and

WHEREAS, a budget amendment has been prepared for the Fiscal Year 2016/17 Road Engineering budget.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Awards the Contract to the low bidder, American Civil Constructors, at the bid price of \$661,000.00 plus a 10% contingency for the contract work items for a grand total of \$727,100.00.
- 2. Authorizes the Chair of the Board of Supervisors to execute on behalf of the County of Nevada the contract between Nevada County and American Civil Constructors upon receipt of Certificates of Insurance by the Director of the Department of Public Works and approval and acceptance of the Certificates of Insurance by the Risk Manager.
- 3. Directs the Auditor-Controller to amend the Department of Public Works Fiscal Year 2016/17 budget as follows:
