WHEREAS, the County of Nevada (950 Maidu Avenue, Nevada City, California 95959) entered into Contract No. 440821 with Hansen Brothers Enterprises (11727 La Barr Meadows Road, Grass Valley CA 95949) on July 11, 2017 by Resolution 17-386 for a contract totaling \$635,289 for the contract work items plus 10% contingency of \$63,529, for a total of \$698,818; and

WHEREAS, said Contract for the Brunswick Road Emergency Slide Repair Project located approximately 1,000 feet south of the East Bennett/Greenhorn Road intersection was constructed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of the Nevada County Department of Public Works on July 27, 2017 with contract costs totaling \$674,672.44.


