OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

PRESOLUTION TO APPROVE THE COLLECTION OF PARCEL CHARGES FOR SOLID WASTE COLLECTION SERVICES IN WESTERN NEVADA COUNTY FOR FISCAL YEAR 2024/25

WHEREAS, the Director of the Department of Public Works has prepared the Parcel Charges from various County Service Areas and Tax Rate Areas contained within Western Nevada County in fiscal year 2024/25; and

WHEREAS, the Parcel Charges are in conformance with Ordinance No. 2319 and as temporarily reduced per Resolution 23-272 as follows:

Single Family Residential	\$44.54 per year	
Multi-Family Residential	\$34.70 per unit/year	
Mobile Home Space (In mobile home parks)	\$31.08 per unit/year	
Non-residential Parcel:	\$27.19 per ton	; and

WHEREAS, Government Code Sections 25213 and 25827 authorize the collection of Solid Waste fees in County Service Areas, Government Code section 25823 allows for the collection of fees related to disposal facilities, and Government Code section 25830(c) allows for the charges to be collected and placed on the secured tax roll.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes the collection of parcel charges in fiscal year 2024/25 in the following County Service Areas and Tax Rate Areas:
