SUBJECT: Resolution approving Amendment 1 to the contract between County of Nevada and Fire Safe Council of Nevada County for the provision of fire prevention and education activities in Nevada County to increase the contract amount from \$60,000 to \$78,000 and expand the scope of services for the period July 1, 2019 through June 30, 2020, authorizing the Chair of Board of Supervisors to execute the contract, and amending the Office of Emergency Services FY 2019/20 Budget (4/5ths affirmative vote required)

RECOMMENDATION: Adopt the Resolution

FUNDING: These services are being funded from Prop 172 allocations in an amount not to exceed \$60,000 and paid from the FY 2019-20 Emergency Management budget. The additional \$18,000 will be paid from Emergency Management general fund budget. A budget amendment has been included for approval.

BACKGROUND: The Board of Supervisors, in its commitment to reduce the risk of wildfire and the effects of wildfire on life, property, and the environment, has allocated funds to the Office of Emergency Services from the County's Proposition 172 Public Safety revenues.

On July 23, 2019, per Resolution 19-418, the Nevada County Board of Supervisors approved a renewal contract with the Fire Safe Council of Nevada County for the Fiscal Year 2019-20 in the amount of \$60,000 to provide for the provision of fire prevention and education activities in Nevada County. This Amendment One will expand the scope of services to allow the certification of 15 new Firewise Communities in this Fiscal Year 2019-2020, provide support to the Fire Safe Council of Nevada County for the cost of venue rental for Firewise Coalition of Nevada County meetings, and will increase the Maximum Contract Price by \$18,000 to a new contract total of \$78,000. In all other respects, the prior agreement of the parties shall remain in full force and effect except as amended herein.
