OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

APPROVAL OF CONTRACT AMENDMENT NO. 6 WITH ADKO ENGINEERING FOR THE MAYBERT BRIDGE REPLACEMENT PROJECT NEAR THE TOWN OF WASHINGTON IN EASTERN NEVADA COUNTY "CANYON CREEK BRIDGE NO. 17C-0030" OVER CANYON CREEK - CONTRACT NO. 224017 – DISTRICT V

WHEREAS, the Nevada County Board of Supervisors, by Resolution 08-323, awarded the contract to ADKO for Bridge Design Services for a single lane bridge on Maybert Road in Eastern Nevada County "Canyon Creek Bridge No. 17C-0030"; and

WHEREAS, the preceding amendments for services are as follows: Amendment 1 was approved by Resolution 08-386 on August 14, 2008, Amendment 2 was approved by Resolution 09-197 on May 26, 2009, Amendment 3 was approved by Resolution 11-048 on January 25, 2011, Amendment 4 was approved by Resolution 12-498 on December 11, 2012, and Amendment 5 was approved by Resolution 15-145 on April 14, 2015; and


WHEREAS, the Department recommends extending the contract expiration date from March 31, 2016 to December 31, 2016; and

WHEREAS, Federal Highway Bridge Replacement Funds and State Exchange Funds are available to accomplish this project in budget code 1114-30154-702-3000/540712; and

WHEREAS, construction of the project is scheduled for the summer of 2016.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves Contract Amendment No. 6 and authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and ADKO.
- 2. Approves changing the contract expiration date from March 31, 2016, to December 31, 2016.

AMENDMENT NO. 6 TO THE CONTRACT WITH ADKO ENGINEERING

THIS AMENDMENT is executed this <u>22nd</u> day of <u>March</u>, 2016, by and between ADKO ENGINEERING and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Contract for Bridge Design Services for a Single Lane Bridge on Maybert Road in Eastern Nevada County "Canyon Creek Bridge No. 17C-0030" executed on July 8, 2008, by Resolution No. 08-323. The contract was subsequently amended by Resolution Numbers 08-386, 09-197, 11-048, 12-498, and 15-145.
