# RESOLUTION No. 23-167

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND J.W. BAMFORD, INC., FOR THE HAZARD TREE REMOVAL PROJECT, AMENDING THE SCOPE OF SERVICE, PROJECT WORKING DAYS, AND INCREASING THE CONTRACT AMOUNT TO A NEW MAXIMUM AMOUNT NOT TO EXCEED \$413,436.73 AND AUTHORIZING THE AUDITOR-CONTROLLER TO ENCUMBER THE ADDITIONAL FUNDS

WHEREAS, on October 25, 2022, the Board of Supervisors adopted Resolution 22-551 awarding a contract to J.W. Bamford, Inc. for the Hazard Tree Removal Project in the amount of \$203,436.73; and

WHEREAS, the February-March Winter Storm of 2023 caused many trees and limbs to break due to the immense amount of snowfall in a short amount of time. Much of this debris fell within County right-of-way and needs to be removed for public safety and as part of the County's fire prevention program; and


WHEREAS, on March 1, 2023, the State of California issued a Proclamation of a State of Emergency that included Nevada County and on March 7, 2023, the Board of Supervisors of the County of Nevada also issued a Proclamation of Existence of a Local Emergency in order to respond to the storm damage more effectively; and

WHEREAS, the Department of Public Works is requesting that the Board of Supervisors approve this amendment to the contract with J.W. Bamford, Inc., in the amount of \$210,000.00, increasing the current amount from \$203,436.73 to \$413,436.73 and increasing the contract working days from 90 days to 120 days, and amend the scope to include Exhibit A and Exhibit B, attached; and

WHEREAS, sufficient budget is available to fund this amendment through the current CAL FIRE grant, 5GA21115, issued on May 4, 2022, and accepted by the Board of Supervisors on May 24, 2022, by Resolution 22-229; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors of the County of Nevada, State of California:

- 1. Approves Amendment No. 1, attached hereto, to the contract by and between the County of Nevada and J.W. Bamford, Inc., amending the scope of services, increasing the contract amount by \$210,000.00 for a maximum not to exceed amount of \$413,436.73 and extending the contract working days from 90 days to 120 day.
- 2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County Amendment No. 1.
- 3. Authorizes the Auditor-Controller to encumber the contract: 1114-30104-702-1000 / 521520 \$210,000.00

## AMENDMENT NO. 1 TO COUNTY PROJECT 715002 WITH J.W. BAMFORD, INC.

THIS AMENDMENT is executed this 25<sup>th</sup> day of April 2023, by and between J.W. BAMFORD, INC. and COUNTY OF NEVADA. Said amendment will amend the prior contract for the Hazard Tree Removal Project, County Project No. 715002, executed on the October 25, 2022, by Resolution 22-551.

WHEREAS, the parties desire to amend their agreement to increase the scope of work to allow for storm debris removal, increase the contract working days from ninety (90) to one hundred and twenty (120), and allow or provide an additional two hundred and ten thousand dollars (\$210,000.00) for a not to exceed amount of four hundred thirteen thousand four hundred thirty-six and seventy-three cents (\$413,436.73); and

WHEREAS, this amendment shall be effective when signed by both parties.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. Extend the contract working days to 120 days.
- 2. That the Maximum Contract Price set forth is increased by two hundred and ten thousand dollars (\$210,000.00) for the new not to exceed amount of four hundred thirteen thousand four hundred thirty-six and seventy-three cents (\$413,436.73).
- 3. The original scope of work is amended to include "Exhibit A" attached.
- 4. That in all other respects the prior agreement of the parties shall remain in full force and the effect except as amended herein.

### EXHIBIT A SCOPE OF WORK

<u>Item 1:</u> Remove remaining storm debris from the February/March 2023 Winter Storm along approximately 70 miles of County maintained roadways as listed in Exhibit B. Removal of this material will include the following:

- 1. Removal of all storm debris including fallen trees of all sizes, broken limbs, and small branches larger than 1 inch in diameter and 1 foot in length, and litter under 20 pounds (only in areas with storm debris damage) on both sides of the road that rests within 15 feet from the road edge.
- 2. Any downed trees that extend past 15 feet from the road edge shall be cut at the limit line and that section is to be removed.
- 3. All cleared storm debris including wood chips shall be removed and disposed of offsite and is the sole responsibility of the contractor.
- 4. Sweeping shall be done before moving onto the next area and as required to remove any loose material. Contractor shall clear roadways, driveways, ditches and gutters of cleared material.
- 5. Contractor may choose to work on any road group in any order. It is not required to work on the roads in the order they are listed.
- 6. The contractor shall notify the Public Works Inspector of any large items of trash or other discarded items that are encountered within the storm debris areas. It shall not be the Contractor's responsibility to dispose of any single item in excess of 20 pounds in weight.

#### Additional Notes:

- 1. Submit an updated traffic plan that includes specific rolling traffic plan for storm debris removal.
- 2. See additional Force Account worksheets, changes to sheets are at the discretion of Director of Public works
- 3. Exact quantities of debris removed to be determined in the field and paid per load according to the rate sheet.
