SUBJECT: Resolution approving execution of Amendment No. A05 to the renewal Standard Agreement Number 14-90076 between the County and the California Department of Health Care Services (DHCS) which 1) modifies the terms and conditions; 2) amends the funding amounts for Fiscal Years 2014/15, 2015/16 and 2016/17; and 3) increases the total contract maximum from \$3,123,131 to \$3,123,695 (an increase of \$564) for Substance Use Disorder Services for the term of July 1, 2014 through June 30, 2017.

RECOMMENDATION: Approve the attached Resolution.

FUNDING: This Agreement provides for federal SAPT (Substance Abuse Prevention and Treatment) Block Grant funding; anticipated Federal Financial Participation for Drug Medi-Cal; and anticipated Drug Medi-Cal State funding. A budget amendment is not necessary and there are no county general fund dollars required in this Agreement.

BACKGROUND: The California Department of Health Care Services contracts with counties for the provision of alcohol and drug prevention and treatment services. Per Resolution No. 14-507, the board approved the original three year Agreement which provides funding for the purpose of identifying and providing for covered Drug Medi-Cal (DMC) services for substance use treatment and prevention in the County's service area. The Agreement allocates Substance Abuse Prevention and Treatment (SAPT) Block Grant funds for planning, carrying out, and evaluation activities to prevent and treat substance abuse, and reimbursement based on the amount and type of Drug Medi-Cal services provided to clients. The Board subsequently approved four Amendments for the purpose of increasing fiscal year funding levels per Amendment A01 (Resolution No. 15-200);

Amendment A02 (Resolution No. 15-441); Amendment A03 (Resolution No. 16-085); and Amendment A04 (Resolution No. 16-113).

The funding received from this Agreement is used to support in-house staff/services and a wide array of contracted services to best meet the prevention and treatment needs of residents. Services provided may include substance abuse assessments, primary and secondary prevention, non-residential treatment (outpatient and aftercare), residential treatment services and outpatient perinatal treatment programs, and to provide residents with information, resources and referrals.

It is recommended that the Board approve the attached Amendment A05, which modifies the terms and conditions and increases funding for each fiscal year, as it provides essential program funding for alcohol/drug dependency treatment and preventive services to meet the level of service demands of county residents.
