## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION TO ESTABLISH AND ADOPT A REVISED FEE SCHEDULE FOR THE SHERIFF'S OFFICE AND TO RESCIND RESOLUTION 93-545**

WHEREAS, the Sheriff's Office has the responsibility for administering and enforcing compliance with local ordinances as well as California State laws; and

WHEREAS, the Sheriff's Office has gathered information on the cost of providing its various services and has proposed a fee schedule based on those costs; and

WHEREAS, the County of Nevada desires these fees to be fair and equitable to the recipients of such services and County taxpayers; and

WHEREAS, many of the fees have not been adjusted since 1993 when Resolution 93-545 was adopted, which established fees based on the cost of services at that time; and

WHEREAS, the County of Nevada desires to adjust these fees to recover or partially offset increased costs of providing these services and add fees for certain services as allowed by law; and

WHEREAS, the County of Nevada desires to include subsequent annual adjustments to these fees, except for those fees which are statutorily or otherwise restricted or determined,, for a five year period, with each annual adjustment to be based on the percentage change in the Consumer Price Index (CPI) for urban wage earners and clerical workers in the State of California for the previous twelve months ending in December as published by the State of California Department of Industrial Relations; and

WHEREAS, concurrently with adoption of this resolution, the Nevada County Board of Supervisors is introducing an Ordinance that will amend certain sections of the Administrative and General Codes allowing fees to be set by resolution; and

WHEREAS, to implement said Ordinance, the Nevada County Sheriff's Office has prepared a Schedule of Fees, which also includes hourly rates that the Sheriff may collect, a copy of which is attached hereto as Exhibit "A", and which will become effective after the effective date of the proposed Ordinance; and

WHEREAS, notice of a public hearing was duly published on or about May 27, 2016.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, that the Sheriff's Office fees as set forth in Exhibit "A" attached hereto are hereby adopted and shall be effective as of August 7, 2016.

BE IT FURTHER RESOLVED that the Sheriff's Office, in conjunction with the CEO's Office and the Auditor-Controller, shall annually adjust all fees set forth in Exhibit "A", except for those fees which are statutorily or otherwise restricted or determined, with each annual adjustment to be based on the percentage change in the Consumer Price Index (CPI) for urban wage earners and clerical workers in the State of California for the previous twelve months ending in December as published by the State of California Department of Industrial Relations. The annual adjustments shall be calculated, and notice of changes shall be provided to the public, on or before April 30, 2017 and on each April 30 thereafter, and shall be effective as of July 1<sup>st</sup> of each following fiscal year. This authorization for annual fee adjustments shall be effective for a period of five fiscal years, through and including fiscal year 2020-21.

BE IT FURTHER RESOLVED that the Sheriff may administratively adjust the amounts of State adopted and imposed fees as necessary and will notice the public annually of such changes.

BE IT FURTHER RESOLVED that Resolution 93-545 is hereby rescinded in its entirety.
