

## RESOLUTION No. 16-120

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

APPROVAL OF CONTRACT AMENDMENT NO. 1 WITH NELSON ENGINEERING FOR PROFESSIONAL SURVEYING SERVICES FOR COUNTY SURVEYOR FUNCTIONS AND AMENDING THE FISCAL YEAR 2015/16 BUDGET FOR THE SURVEYOR FUND (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, On June 23, 2015 the Board of Supervisors approved Resolution 15-283, approving a renewal contract with Nelson Engineering for professional surveying services for county surveyor functions for a not-to-exceed contract amount of \$115,000; and

WHEREAS, the County's Planning Department wishes to utilize Nelson Engineering for surveying services related to the Emigrant Trail project; and


WHEREAS, while this work is included in the contract scope of services, the costs to provide these services will exceed the amount included in the original contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves Contract Amendment No. 1 and authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Nelson Engineering.
- 2. Directs the Auditor-Controller to amend the Surveyor Fiscal Year 2015/16 budget increasing the following revenue and expenditure accounts:

3. Approves increasing the maximum not to exceed contract amount to \$145,000 to provide sufficient funds for professional surveying services for county surveyor functions.

## AMENDMENT NO. 1 TO THE CONTRACT WITH NELSON ENGINEERING

THIS AMENDMENT is executed this <u>22nd</u> day of <u>March</u>, 2016, by and between NELSON ENGINEERING and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled "Provide County Surveyor Services", executed on July 1, 2015 by Resolution No. 15-283.

WHEREAS, the parties desire to amend their agreement; and

WHEREAS, this amendment shall be effective when signed by both parties.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. Increase the total maximum not to exceed contract amount from \$115,000 to \$145,000.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
