RESOLUTION APPROVING CONTRACT AMENDMENT NO. 1 WITH NELSON ENGINEERING FOR PROFESSIONAL SURVEYING SERVICES FOR AN INCREASE OF \$45,000 FOR COUNTY SURVEYOR FUNCTIONS AND AMENDING THE FISCAL YEAR 2023/24 BUDGET FOR THE SURVEYOR FUND (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on June 13, 2023, the Nevada County Board of Supervisors adopted Resolution 23-260, approving a contract with Nelson Engineering for professional surveying services from July 1, 2023, through June 30, 2024, with up to four (4) one-year renewals starting July 1, 2023; and

WHEREAS, additional services are required for processing land development projects, and other surveying services; and


WHEREAS, the parties desire to increase the contract amount by \$45,000 for a new not to exceed amount of \$145,000; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, approves Amendment No. 1, attached hereto as Exhibit A, to the professional services contract by and between the County of Nevada and Nelson Engineering, increasing the contact amount by \$45,000 for a maximum not to exceed amount of \$145,000, the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 1, and directs the Auditor-Controller to encumber the contract amendment and amend the County Surveyor budget as follows:
