OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AN AGREEMENT WITH PARTNERSHIP HEALTHPLAN OF CALIFORNIA (PHC) ALLOWING THE NEVADA COUNTY PUBLIC HEALTH DEPARTMENT TO RECEIVE REIMBURSEMENT FOR COMMUNITY HEALTH WORKER (CHW) SERVICES PROVIDED TO MEDI-CAL MANAGED CARE PLAN MEMBERS, WITH THE AGREEMENT AUTOMATICALLY RENEWING AT ONE-YEAR INTERVALS UNTIL TERMINATED BY EITHER PARTY

WHEREAS, California Advancing and Innovating Medi-Cal (CalAIM) is a Department of Health Care Services (DHCS) initiative to transform the Medi-Cal delivery system; and

WHEREAS, Community Health Worker (CHW) services are a statewide Medi-Cal benefit administered through each county's Medi-Cal Managed Care Plans that may assist with a variety of concerns impacting MCP members, including but not limited to, the control and prevention of chronic conditions or infectious diseases, behavioral health conditions, and need for preventive services; and

WHEREAS, Partnership Health Plan of California (Partnership) is the Medi-Cal Managed Care Plan in Nevada County; and

WHEREAS, the Nevada County Public Health (NCPH) already provides CHW services to PHC members; and

WHEREAS, by entering into this Agreement the NCPH will be able to receive reimbursement from PHC when the Department provides these services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Agreement with the Partnership HealthPlan of California for reimbursement of CHW services at the established rate(s) provided to members for a term commencing September 1, 2025, and remaining in effect until terminated be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada.
