BACKGROUND:

Currently there is one vacancy and three positions available for the Nevada-Sierra Connecting Point Public Authority Governing Board. One public representative vacancy to fill unexpired three-year term ending June 30, 2024. One public representative and two consumer representative positions beginning on July 1, 2023 for three-year term ending June 30, 2026. The vacancy and positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Nathalie Ennis submitted an application for reappointment as Consumer Member representative to the Nevada-Sierra Connecting Point Public Authority Governing Board on May 31, 2023. Nathalie has served as Consumer Member representative since December 15, 2020.

Nikki Bowden submitted an application for reappointment as Consumer Member representative to the Nevada-Sierra Connecting Point Public Authority Governing Board on May 31, 2023. Nikki has served as Consumer Member representative since October 10, 2017.

Remy Lindsey submitted an application for reappointment as Public Member to the Nevada-Sierra Connecting Point Public Authority Governing Board on May 31, 2023. Remy has served as Consumer Member representative since June 28, 2022.

All members are in good standing and are recommended for reappointment by the board.

Please consider reappointing Nathalie Ennis and Nikki Bowden as Consumer Member representatives and Remy Lindsey as Public Member representative to the Nevada-Sierra Connecting Point Public Authority Governing Board for three-year terms ending June 30, 2026.
