**SUBJECT:** Resolution re-appointing Robert Ingram and Susan Hoek and appointing James Drew to the Nevada County Resource Conservation District

---

**RECOMMENDATION:** Re-Appoint Robert Ingram and Susan Hoek and Appoint James Drew to four year terms on the Nevada County Resource Conservation District, ending November 27, 2020.

**FUNDING:** N/A.

**BACKGROUND:** The Local Agency Formation Commission's Municipal Service Review for the Nevada County Resource Conservation District outlined that the potential cost of elections in both Nevada and Sierra counties could pose a tremendous financial burden on the Resource Conservation District.

Pursuant to Public Resources Code Section 9314(b)(1), the Nevada County Resource Conservation District Board of Directors, at its May 9, 2006, regular meeting, adopted Resolution 96-01, changing the method of selection of its Board of Directors from elected to appointed officials and requesting the County of Nevada Board of Supervisors to appoint Directors. At its meeting of July 11, 2006, the County of Nevada Board of Supervisors took action to appoint director positions to the Nevada County Resource Conservation District.

Three positions on the Nevada County Resource Conservation District became vacant on November 30, 2016, and the notice of vacancy was posted as required by law. Four applications were submitted to the Board of Supervisors and one application was withdrawn. The Nevada County Resource Conservation District Board recommends approval of the re-appointment of Robert Ingram and Susan Hoek and the appointment of James Drew to four year terms on the Nevada County Resource Conservation District

Public Resources Code PRC 9314(b) (1) directs that "The Board of Supervisors shall appoint directors, after consultation with the Board of Supervisors of any other county which contains any part of the District, from those candidates who have filed an application." A portion of the District is located in Sierra County. At their meeting of December 6, 2016, the Sierra County Board of Supervisors approved the re-appointment of Robert Ingram and Susan Hoek and the appointment of James Drew to four year terms on the Nevada County Resource Conservation District
