



RESOLUTION No. 25-442

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING A MULTI-YEAR SITE LICENSE AGREEMENT WITH THE COUNTY OF PLACER FOR PUBLIC SAFETY RADIO COMMUNICATION EQUIPMENT VAULT SPACE AT APN 015-110-037-000 IN CISCO GROVE, CALIFORNIA, WITH A TERM OF 10 YEARS COMMENCING ON OCTOBER 1, 2025

WHEREAS, one of the responsibilities of the Nevada County Sheriff's Office is to provide Regional Dispatch Services for the County; and

WHEREAS, operators at the Regional Dispatch Center communicate with patrol officers via radio; and

WHEREAS, due to the rough terrain in the County, radio communication equipment is housed throughout the County and surrounding areas to provide optimal radio signal coverage; and

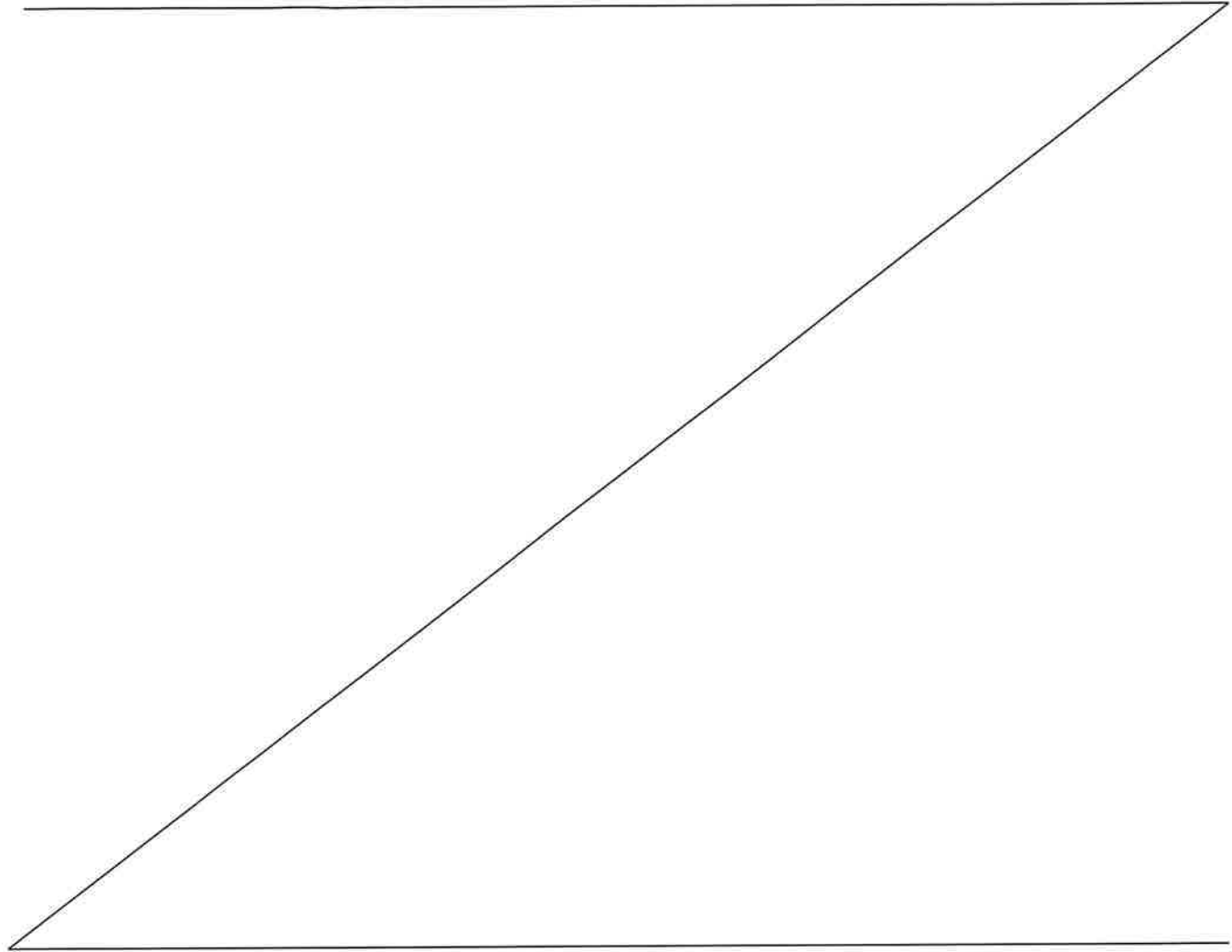
WHEREAS, in May of 2020 the Nevada County Board of Supervisors authorized a License Agreement with Placer County (RES 20-140) to locate radio communication equipment at the Cisco Grove site location and this will continue to be operational until the new upgraded radio communications system is live and functioning; and

WHEREAS, the Sheriff's Office requires additional vault space for new radio communications system and wishes to enter into an additional site License Agreement for additional radio communication equipment vault space with the County of Placer at APN 015-110-037-000 in Cisco Grove, California for the same purpose; and

WHEREAS, the County of Placer is offering a site license agreement to provide radio communications equipment vault space for a period of up to 10 years for this additional equipment space, for the period commencing October 1, 2025. The first-year rent is \$2,100.00 per month payable to the County of Placer, Department of Facilities Management, in advance on the first of each month. The payments will increase three percent per year. All increases shall be on the anniversary of this license agreement.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Nevada County Board of Supervisors, State of California, that the Site Lease Agreement with the County of Placer to provide public safety radio communication equipment vault space at APN 015-110-037-000 in Cisco Grove, California, in the maximum initial annual amount of \$25,200.00, for the ten-year period commencing October 1, 2025, thereafter increasing at 3% per annum, is approved and authorizes the Sheriff or her designee to execute the Site License Agreement.
