**SUBJECT:** Resolution to award the contract for the 2025 Western Nevada County Annual Striping Project to Traffic Limited for a total not to exceed amount of \$112,577.89 under County project number 426643 – All Districts

**RECOMMENDATION:** Approve the attached resolution.

**FUNDING:** The 2025 Western Nevada County Annual Striping Project will be funded by the Road Maintenance and Rehabilitation Act (RMRA) and is included in the Road Engineering budget for Fiscal Year 25/26. There is no impact to the General Fund.

**BACKGROUND:** On 4/22/2025 the Nevada County Board of Supervisors approved Resolution 25-142 to authorize the Purchasing Agent to solicit bids for the 2025 Western Nevada County Annual Striping Project. These bids were opened on 6/5/2025, and are listed below:

Bidder	Total Bid
1. Traffic Limited	\$102,343.54
2. Central Striping	\$135,943.41
3. Nevada Barricade & Sign	\$168,293.10

**Engineer's Estimate** **\$147,000.00**

It is recommended that the contract be awarded to the low bidder, TRAFFIC LIMITED at the bid price of \$102,343.54, plus a 10% contingency of \$10,234.35 for a total not to exceed amount of \$112,577.89. Work is expected to begin in August 2025.
