RESOLUTION AUTHORIZING EXECUTION OF AN AMENDMENT TO THE AGREEMENT APPROVED BY RESOLUTION 12-353 EXTENDING THE TERM OF THE AGREEMENT WITH THE COUNTY OF SIERRA TO HOUSE SIERRA COUNTY INMATES AT THE NEVADA COUNTY JAIL

WHEREAS, the parties have previously entered into an inmate housing Agreement authorized by Resolution 12-353, which expired on June 30, 2017; and

WHEREAS, the parties wish to amend the Agreement, by extending the contract termination date by one year until June 30, 2018; and

WHEREAS, in all other aspects, the Agreement, as amended, and any attachments, remains in full force and effect.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Chair of the Board of Supervisors, of the County of Nevada, be and is hereby authorized to execute, on behalf of the County of Nevada, that certain Amendment to the contract with the County of Sierra pertaining to inmate housing, for the period June 30, 2017 to June 30, 2018.

NOW, THEREFORE, the parties hereto agree as follows:


1. This amendment shall be effective as of September 19, 2017.
