RESOLUTION APPROVING AMENDMENT NO. 1 TO A CONTRACT WITH CASCADE SOFTWARE SYSTEMS, INC. FOR SOFTWARE MAINTENANCE, INSTALLATION, TRAINING, AND CUSTOM PROGRAMMING FOR FISCAL YEAR 2018/19 FOR A MAXIMUM CONTRACT AMOUNT OF \$43,378 AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT AMENDMENT (RESOLUTION 18-373)

WHEREAS, the Nevada County Public Works Department has been using Cascade Software Systems, Inc. for their Road Maintenance and Road Engineering Divisions' cost accounting software system vendor since 2001; and

WHEREAS, the Nevada County Public Works Department requires custom programming and training this fiscal year; and

WHEREAS, the onsite training will require that Cascade Software Systems Inc. include Commercial Automobile insurance with an endorsement naming the County as an additional insured; and

WHEREAS, this contract amendment only modifies the contract to require said commercial automobile insurance.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves contract Amendment No. 1 between Nevada County and Cascade Software Systems Inc.
2. Authorizes the Chair of the Board of Supervisors to execute on behalf of the County of Nevada the Amendment No. 1 between Nevada County and Cascade Software Systems Inc.

**AMENDMENT TO CONTRACT WITH
CASCADE SOFTWARE SYSTEMS, INC.**

THIS AMENDMENT is executed this 9th day of October, 2018 by and between CASCADE SOFTWARE SYSTEMS INC. and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled CAMS SOFTWARE ANNUAL MAINTENANCE, INSTALLATION, TRAINING AND CUSTOM PROGRAMMING executed on July 17, 2018 by Resolution No18-373.

WHEREAS, the parties desire to amend their agreement to allow or provide for a change in automobile insurance requirements; and

WHEREAS, parties agree that commercial automobile insurance is required for the scope of this contract; and

NOW, THEREFORE, the parties hereto agree as follows:

1. This amendment shall be effective as of October 9, 2018.
2. That paragraph (§7) shall be changed to mark that Commercial Automobile Policy is Required.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
