RESOLUTION APPROVING EXECUTION OF AMENDMENT 1 TO THE CONTRACT WITH VICTOR COMMUNITY SERVICES, INC FOR THE PROVISION OF COUNSELING AND PSYCHIATRIC SERVICES TO ADJUST LINE ITEMS WITH THE MAXIMUM CONTRACT PRICE NOT CHANGING, FOR A MAXIMUM PRICE OF \$363,040 AND REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE LINE-ITEM ADJUSTMENTS FOR THE TERM OF JULY 1, 2024, THROUGH JUNE 30, 2025 (RES. 24-373)

WHEREAS, on July 9, 2024, per Resolution 24-373 Nevada County Board of Supervisors authorized the execution of the Professional Services Contract between the County of Nevada and Victor Community Services, Inc for the provision of counseling and psychiatric services; and

WHEREAS, the parties desire to amend their Agreement to adjust the line items in the contract with the maximum contracting price not changing for the maximum price of \$363,040 and amend Exhibit "B" Schedule of Charges and Payments to reflect the line item adjustments.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 1 to the Professional Services Contract by and between the County and Victor Community Support Services, Inc. pertaining to the provision of counseling and psychiatric services in the maximum amount of \$363,040 for the term of July 1, 2024, through June 30, 2025, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

AMENDMENT #1 TO THE CONTRACT WITH VICTOR COMMUNITY SERVICES (RES. 24-373)

THIS AMENDMENT is executed this August 20, 2024 by and between VICTOR COMMUNITY SERVICES, hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County". Said Amendment will amend the prior Agreement between the parties entitled Professional Services Contract, executed on July 9, 2024 per Resolution 24-373; and

WHEREAS, the Contractor provides counseling and psychiatric services; and

WHEREAS, the parties desire to amend their Agreement to adjust line items in the contract with the maximum contract price not changing, for a price \$363,040 and amend Exhibit "B" Schedule of Charges and Payments to reflect the line adjustments.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That Amendment #1 shall be effective as of July 1, 2024.
- 2. That Maximum Contract Price, shall be amended to the following: \$363,040.
- 3. That the Schedule of Charges and Payments, Exhibit "B" is amended to the revised Exhibit "B" attached hereto and incorporated herein.
- 4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

Should the categories budgeted above change by more than ten percent (10%); a budget modification shall be submitted for approval. The Department of Social Services at its sole discretion shall determine if the change in the operating budget will continue to meet the outcomes of the Agreement.

CONTINGENCY

Contract maximum is contingent and dependent upon the County's annual receipt of anticipated State/Federal Funds for contract services.

BILLING AND PAYMENT

Contractor shall submit an invoice to County by the 25th of each month following the month services were rendered. Each invoice shall include:

- Dates/Month/hours of services rendered
- Cost of services rendered identifying total direct costs
- Billing period covered
- Contract Number assigned to the approved contract
- Unique invoice number for each invoice submitted
- Supporting documentation

County shall review each billing for supporting documentation, dates of services, and costs of services as detailed previously. Should there be a discrepancy on the invoice, said invoice shall be returned to Contractor for correction and/or additional supporting documentation. Payments shall be made in accordance with County processes once an invoice has been approved by the Department.

BILLING AND PAYMENT EXCEPTION

By the twenty-fifth of June each year, Contractor shall provide an invoice for services rendered for the month of May. An invoice of services provided for the month of June shall be provided no later than the fifth of August.
