



On behalf of my clients, and as a long-time Nevada County resident, I wish to state for the record our strong objection to your proposed Ordinance. On its face, and certainly as it may be applied in the future, the draft Ordinance is fatally flawed in numerous respects. It is vague and over-broad, lacks a compelling rationale for limiting Constitutionally protected behavior, unlawfully delegates authority to

the Executive Branch of State government to describe illegal behavior, elevates guidelines into potentially criminal offenses in an impermissible blanket manner, is an illegitimate exercise of the police power of the State, is not based upon specific legislatively granted authority, unlawfully seeks reimbursement of fees and costs in advance of "conviction", may constitute an unlawful taking of private property which will require compensation by the County, as well as numerous other flaws and over-reaches of authority.

This Ordinance will not withstand judicial review, and rest assured it will be vigorously challenged if necessary. I urge you to please consider the impacts of further damaging our local economy at a time when our County has been and remains comparatively untouched by the threat of the "Covid" virus. In short, at least at the present time, it is difficult to make the case that there is a sufficient "emergency" here locally that could possibly justify your proposed action. In the end, you may find it creates more liabilities for the County. I add my support to the email sent by Frank Bloksberg in support of a new ordinance to enforce public health guidelines during Covid-19.

To the Nevada County Board of Supervisors,

I am a lawyer (practicing since 1990) and have lived in Nevada County for 25 years. I care deeply about this community and that we have a safe place to live.

I urge you to reject the messages that support Friar Tuck's continued lawbreaking. Please immediately pass the COVID ordinance so that you can continue to protect public health.

I have seen what I understand is a message sent on behalf of Friar Tuck's. The message asks people to support the business in violating State and local law related to the COVID epidemic. In addition, the message gives some explanations and arguments for why people should support the business' violating the law and endangering public health.

The message I read begins,

"To All!

Friar Tuck's is at a major cross road in history."

Even if the message does not reflect Friar Tuck's views and arguments, it still reflects many of the arguments people are offering to ignore COVID orders and support law-breaking restaurants.

Since the explanations in the message are not based in fact or law, I urge you to reject the message in its entirety.

Much of the message's content is conspiracy nonsense. The arguments about the legal and factual basis for the health orders are cut-and-pasted from conspiracy websites that have no credibility at all. You should summarily reject these arguments for the nonsense that they are.

I will give you two examples of the completely law-free and factually disingenuous nature of the arguments. The message states,

"In violation of well-established legal precedent from Jew Ho v. Williamson, 103 F. 10, 26 (C.C.N.D. Cal. 1900) and subsequent public health law, arbitrary and capricious rules were inflicted upon a part of the population that were not applied generally, resulting in the unlawful confinement of a healthy population with no basis in science or fact."

In the Jew Ho case, a California court found that sealing off an entire section of San Francisco to prevent the spread of the bubonic plague was "unreasonable, unjust, and oppressive."

The case involved a racially-motivated and scientifically-unfounded quarantine of San Francisco's Chinatown. The City had quarantined Chinatown claiming that people were dying from bubonic plague. No evidence existed that anyone had plague, let alone were dying from it. Of course, the court held that the quarantine was "unreasonable, unjust, and oppressive."

The Jew Ho case has nothing to do with how we should handle the COVID disaster. The message's author might know that if they were actually arguing in good faith rather than copying-and-pasting conspiracy nonsense.

In essence, the message argues that Friar Tuck's knows how to protect public health better than elected officials and public health experts. For that reason, the message urges that we simply trust the business owners. Along those lines, the message states,

"We have made Friar Tuck's the safest place to be! Friar Tuck's announces 'Bipolar Ionization' 99.4% of all viral particles destroyed."

The message then includes cut-and-pasted information from the filter's manufacturer about how effective the equipment is. The message, however, misrepresents and misconstrues what the manufacturer actually says about its products.

The manufacturer, Global Plasma Solutions, provides a white paper, with a chart, that describes the results of certain tests. Since the white paper does not explain the testing in any way, we cannot know how credible the results are (even assuming that the white paper accurately describes the test results).

A quick review of the chart, and the verbiage introducing the chart, shows that the information is worse than useless. One cannot possibly rely on the information.

In essence, the chart asserts that, over time, certain pathogens can be largely eliminated under test conditions using "ions produced by NPBI" – whatever that means. The white paper does not even try to suggest that the testing is applicable to real world conditions.

Nonetheless, the chart asserts that almost all of certain pathogens (not including COVID-19) can be destroyed – in un-described test conditions – in between 15 minutes and one hour. In other words, the manufacturer acknowledges that the pathogens stay in the air for long periods of time before they become "inactive or non-viable."

Not only do the pathogens remain in the air for a long time potentially infecting people. Customers going in and out of a restaurant and continually reinfecting the place makes questionable, slow filtering cold comfort.

The manufacturer says we cannot rely on its filtering to protect the public:

"The use of this technology is not intended to take the place of reasonable precautions to prevent the transmission of pathogens. It is important to comply with all applicable public health laws and guidelines issued by federal, state, and local governments and health authorities as well as official guidance published by the Centers for Disease Control and Prevention (CDC) (https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html), including but not limited to social distancing, hand hygiene, cough etiquette, and the use of face masks."



#### Dear Supervisors,

I am writing to oppose Item 37, the temporary Urgency Ordinance related to enforcement of COVID-related health department orders. This ordinance is not constitutional and ignores basic human rights of bodily autonomy. The Governor's emergency power in March was triggered by a need to maintain capacity in our hospitals. Our hospitals have plenty of capacity (we currently have ample capacity in our Nevada County hospitals), so this emergency declaration is now ended under the California Constitution. Therefore, Governor Newsom's recent guidelines are illegal and unenforceable.

Why is our County implementing stricter rules than Governor Newsom's current guidelines? Specifically, why does this ordinance propose to fine people for not wearing masks outside in public spaces? Mask wearing has been shown to be physically dangerous in numerous studies (especially for those having to wear them for extended periods of time). It is dangerous for the general public to wear masks without being properly trained in sanitation methods. In addition, there are many who experience psychological trauma when they try to wear a mask. If you choose to pass this ordinance, what accommodations will you be making for individuals who can not wear masks? Who will be held liable for injury resulting from this ordinance? Two children in our community have already passed out after wearing masks for short periods of time.

I implore you to conduct a cost benefit analysis to look at what will be lost in our community versus the benefit of wearing masks. We have had teen suicides, our small businesses are hanging on by a thread, there is now a generation of children who don't know how to socialize and aren't being educated, but the biggest loss is our own right to bodily autonomy. Why are we considering an ordinance that will allow the vulnerable, weak, and fearful to feel comfortable walking around our community while those who are healthy are forced to stay home because they do not want to compromise their health by wearing a mask? The logic in this moment has been overtaken by fear.

Our community is already fighting over this issue. Please don't tear it apart further by passing this unreasonable and unconstitutional ordinance.



To the Nevada County BOS,

I am a resident in District 1, born and raised in Nevada County. I am writing in support of the temporary Urgency Ordinance regarding enforcement of the guidelines set forth to combat the swift spread of COVID 19. Our community had been commandeered by outside political agitators that seem to be taking advantage of a small handful of much-loved local businesses who are struggling, primarily restaurants. These businesses have been led to believe that they have some sort of legal, constitutional protection from the recent public health orders, and have decided to defy those orders.

I supported the "education not enforcement" stand taken by local government initially, but it seems as if this has only empowered this disturbingly growing sentiment that we are somehow immune from the pandemic overtaking many other towns and cities worldwide. There is no reason for the many to be sacrificed for the few, simply because they feel their livelihood is more valuable than anyone else's, and that their lives shouldn't be inconvenienced to save anyone else's. If there are no effective consequences to defying these emergency orders, why should the rest of us struggle so hard to comply? There are over 300 restaurants in this county-the ones creating this division aren't the only ones suffering, and have been given every resource available to adapt. If the other 300+ can limp along for a little while longer, so can they, and if they refuse, the rest of us shouldn't be punished.

I am a cancer survivor with a small child who lives with parents in their late 70s. I am also an essential worker that goes to work every day with a higher than average likelihood of exposure to the virus. The lengths I go to on a daily basis to keep myself, the public I assist, and my family safe are formidable, and exhausting. I find it disheartening and wonder if maybe I should walk away from my work I love to protect me and mine, because these people won't do their part. I'd imagine many essential workers and businesses striving to be responsible feel the same.

We are doing the right thing, for all of us. Please support us and protect us so its not in vain. Please vote yes on this ordinance and provide a tangible consequence for their actions, as their actions have a tangible consequence for the rest of us.

## Dear Supervisors,

I am writing to express my strong opposition to Item 37, the temporary Urgency Ordinance related to enforcement of COVID-related health department orders.

The Governor's emergency declaration in March was generated from a concern of overloading our hospitals. We have flattened the curve, our local hospitals were never overrun, and we have had just over 200 cases in our county, along with one death in Eastern Nevada County. It seems to me that we should be feeling less fear and celebrating our success as opposed to imposing more restrictions and fines that will further divided our already fractured community.

There is much research to prove that wearing cloth face masks do not protect the wearer. COVID virus droplets need to be surrounded by a lipid (fat) in order to survive, and they can easily pass through the cotton mask cloth or simply pass around the side of the mask. Also, the Governor's mandate comes with exceptions as to who does not have to wear face coverings. They are-

- -- Children age 2 and younger.
- -- People with medical, mental health or developmental issues that prevent it.

- -- People who are deaf or have hearing loss and those who communicate with them if seeing someone's mouth is essential.
- -- Workers who would violate workplace safety rules by wearing one.
- -- People eating and drinking at restaurants.
- -- People swimming, walking, hiking, biking, running or doing other outdoor activity where they can stay 6 feet from others.
- -- People in jails and prisons, which have their own guidance on face coverings.

Why are we not honoring those exemptions? What is the liability for the county, the cities and local businesses for forcing people to wear a mask when they are in one of the exempt categories?

Why are we not focusing on helping the members of our community learn how to boost their immune systems and take responsibility for their health from a holistic perspective?

Why hasn't our Health Department enforced OSHA mask regulations to protect the health of workers and the public? There are strict OSHA guidelines that are being completely ignored. What is the liability in this?

Why are you not taking into consideration the collateral damage and deaths from suicide, undiagnosed and untreated medical conditions, increased domestic violence and child abuse, alcoholism. homelessness...?

This ordinance is completely unconstitutional and I am urging you all to do the right thing by voting no on this ordinance.

According to all polls we've seen, we count ourselves in the large majority of folks who understand that the novel coronavirus pandemic is a real thing; this country's chaotic response has been nothing short of disastrous; and it's far beyond time for all of us to roll up our sleeves, put on our masks, stay away from each other, and beat this. That's the only way we'll get to whatever the new, post-pandemic normal will be. But we'll never get there by waving flags and proclaiming our "freedoms" — to infect others? To prolong a pandemic? Sorry, no: Even in the US, most freedoms aren't absolute — except, of course, the liberty to believe whatever we want to. And when we act according to those beliefs, there may be consequences.

Right now, apparently, unfortunately, more consequences are needed. I.e., we support Gov. Newsom's efforts to get ahead of the pandemic, because we're all in this together. And if a particular business believes otherwise, then unless and until they're able to convince the state to change its mind (we hope not), they're stuck with obeying laws and orders designed with public heath in mind. Which means those laws and orders must be enforced, in such a way as to make them more likely to be followed. The County can do — and has done — only so much outreach and education. If some people can't be reached and refuse to be educated, that's on them.

One more thing: We're not anti-small-business or anti-local-business; nor do we think the Governor — or anyone else — has those attitudes. But the answer to those concerns is for us — all of us — to move powerfully toward becoming a much more caring and just society. Caring for others and each other, not only for ourselves. That's why we support, for example, Medicare For All, Housing and Jobs for All — and, during the pandemic and lockdowns, meaningful government assistance for all those who need it. If any society can afford it, it's certainly this one. But we've chosen to live with one of the most shameful wealth-poverty gaps in the world. Let's choose to end it.

And in the meantime, let's choose to protect public health right now. Thanks.



To the Nevada County Board of Supervisors,

I am a lawyer (practicing since 1990) and have lived in Nevada County for 25 years. I care deeply about this community and that we have a safe place to live.

I urge you to reject the messages that support Friar Tuck's continued lawbreaking. Please immediately pass the COVID ordinance so that you can continue to protect public health.

I have seen what I understand is a message sent on behalf of Friar Tuck's. The message asks people to support the business in violating State and local law related to the COVID epidemic. In addition, the message gives some explanations and arguments for why people should support the business' violating the law and endangering public health.

The message I read begins,

"To All!

Friar Tuck's is at a major cross road in history."

Even if the message does not reflect Friar Tuck's views and arguments, it still reflects many of the arguments people are offering to ignore COVID orders and support law-breaking restaurants.

Since the explanations in the message are not based in fact or law, I urge you to reject the message in its entirety.

Much of the message's content is conspiracy nonsense. The arguments about the legal and factual basis for the health orders are cut-and-pasted from conspiracy websites that have no credibility at all. You should summarily reject these arguments for the nonsense that they are.

I will give you two examples of the completely law-free and factually disingenuous nature of the arguments. The message states,

"In violation of well-established legal precedent from Jew Ho v. Williamson, 103 F. 10, 26 (C.C.N.D. Cal. 1900) and subsequent public health law, arbitrary and capricious rules were inflicted upon a part of the population that were not applied generally, resulting in the unlawful confinement of a healthy population with no basis in science or fact."

In the Jew Ho case, a California court found that sealing off an entire section of San Francisco to prevent the spread of the bubonic plague was "unreasonable, unjust, and oppressive."

The case involved a racially-motivated and scientifically-unfounded quarantine of San Francisco's Chinatown. The City had quarantined Chinatown claiming that people were dying from bubonic plague. No evidence existed that anyone had plague, let alone were dying from it. Of course, the court held that the quarantine was "unreasonable, unjust, and oppressive."

The Jew Ho case has nothing to do with how we should handle the COVID disaster. The message's author might know that if they were actually arguing in good faith rather than copying-and-pasting conspiracy nonsense.

In essence, the message argues that Friar Tuck's knows how to protect public health better than elected officials and public health experts. For that reason, the message urges that we simply trust the business owners. Along those lines, the message states,

"We have made Friar Tuck's the safest place to be! Friar Tuck's announces 'Bipolar Ionization' 99.4% of all viral particles destroyed."

The message then includes cut-and-pasted information from the filter's manufacturer about how effective the equipment is. The message, however, misrepresents and misconstrues what the manufacturer actually says about its products.

The manufacturer, Global Plasma Solutions, provides a white paper, with a chart, that describes the results of certain tests. Since the white paper does not explain the testing in any way, we cannot know how credible the results are (even assuming that the white paper accurately describes the test results).

A quick review of the chart, and the verbiage introducing the chart, shows that the information is worse than useless. One cannot possibly rely on the information.

In essence, the chart asserts that, over time, certain pathogens can be largely eliminated under test conditions using "ions produced by NPBI" – whatever that means. The white paper does not even try to suggest that the testing is applicable to real world conditions.

Nonetheless, the chart asserts that almost all of certain pathogens (not including COVID-19) can be destroyed – in undescribed test conditions – in between 15 minutes and one hour. In other words, the manufacturer acknowledges that the pathogens stay in the air for long periods of time before they become "inactive or non-viable."

Not only do the pathogens remain in the air for a long time potentially infecting people. Customers going in and out of a restaurant and continually reinfecting the place makes questionable, slow filtering cold comfort.

The manufacturer says we cannot rely on its filtering to protect the public:

"The use of this technology is not intended to take the place of reasonable precautions to prevent the transmission of pathogens. It is important to comply with all applicable public health laws and guidelines issued by federal, state, and local governments and health authorities as well as official guidance published by the Centers for Disease Control and Prevention (CDC) ([https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-


### Dear Nevada County Supervisors:

Dear Board of Supervisors,

I am writing in the strongest terms possible with compelling information for the Board of Supervisor to vote to terminate this "local health emergency." I ask that this letter be submitted for the public record and added to the upcoming agenda.

The local health emergency and ALL orders emanating from it should be nullified, and not ratified by the Board of Supervisors, based on this irrefutable evidence:

Case increase is not an appropriate perimeter to draw conclusion about the health of our community. The infectious mortality rate is a scientific and appropriate measure to base policy decisions on. Our IMR is well below a justified emergency level.

Further more the PCR test that is being used is not meant to be used to diagnose infectious disease. Anti body tests randomized are more accurate and have less room for false positives unlike the PCR tests. The antibody tests that have been done show a infection rate that was 10X more than what was expected.

### Health officers are violating two California laws:

- 1) Calling for a local health emergency when there are no legal grounds, as defined in California law (ESA 8558 b) and CHSC Section 101080) and
- 2) Not providing "relevant information" to governmental entities, as required by HSC Div 105, Part 1, Chapter 3, Section 120175.5, which directs the health officers to provide evidence and information to the governing body regarding communicable diseases.

If the BOS ratifies these illegal orders, they are complicit in violating these California laws: (ESA 8558 b)

CHSC Section 101080) and

HSC Div 105, Part 1, Chapter 3, Section 120175.5.

### DETAILS:

Health officers are violating California Health and Safety Code section 101080, as follows:

### NO GROUNDS FOR A LOCAL EMERGENCY:

There are no grounds for a local health emergency. According to the California Emergency Services Act (ESA), a *local health emergency* may only be proclaimed by a local health officer when:

- 1) There is a release or spill of material that is subsequently determined to be hazardous or medical waste, or
- 2) There is an "imminent and proximate threat of the introduction of any contagious, infectious, or communicable disease, chemical agent, noncommunicable biologic agent, toxin or radioactive agent"

Based on the definition of the above, there are NO GROUNDS for a local emergency in our county.

There is no imminent [definition: "about to happen"] or proximate [definition: "immediate"] threat.

### Therefore the covid situation does not meet the definition for a local health emergency.

The "introduction" of this disease was declared on February 25, several months ago.

That does not meet the definition of an "introduction" of the disease. The infectious mortality rate is non existent in our county.

### Therefore the covid situation does not meet the definition for a local health emergency.

It is the exact opposite. There has been a slowing of deaths. The mortality rate in the county is not the same as active cases. The mortality is not at an emergency level, our hospitals are not overwhelmed and our resources are not overwhelmed. The numbers of "positive cases" are faulty because of the highly unreliability of the tests which used a PCR test. The PCR test specifically says it should not be used for diagnosis of infectious disease. The most accurate current data is a .4-.26% death or mortality rate. One person has died in our county currently.

Health officers state as a reason for their local health emergency point (5) that "there is currently no vaccine to prevent COVID-19.

How is that a local emergency? There is no effective vaccine for the flu, and there is no local emergency declared for flu season, where fewer county residents die each year, compared to covd-related deaths.

Further, health officers are violating California Health and Safety Code section 101080, as a local health emergency can only be called when there is an "imminent and proximate threat of the INTRODUCTION of any contagious, infectious or communicable disease..."

There is no imminent and proximate threat, and there is no "introduction" of any disease. The introduction happened 3 months ago, so it no longer an EMERGENCY by definition.

### FURTHER, NO EVIDENCE FOR WEARING FACE MASKS:

HSC Div 105, Part 1, Chapter 3, Section 120175.5 states that regarding the administration of communicable disease prevention and control,

"A local health officer must make any relevant information available to governmental entities." This has not happened.

### "Where is the science?"

Health officers have "passed the buck" and are breaking California law by not providing reputable evidence in favor of healthy or asymptomatic residents to wear face masks.

Health officers refer to CDC guidance, which has zero evidence regarding wearing face masks. None of the links provided by the CDC even mention wearing masks, let alone if they are effective.

Further, Health officers rely on guidance from the CDP as the evidence for the mask mandate.

Yet, here is what the CDPH states regarding face masks:

1. The CDPH states: (link is here)

"Our best community and individual defense against COVID 19 is <u>washing our hands</u> frequently, <u>avoiding touching our eyes</u>, <u>nose and mouth</u> with unwashed hands, <u>avoiding being around sick people</u> and physical distancing, especially by staying at home.

2. "Face coverings may increase risk if users reduce their use of strong defenses,"

"You may CHOOSE to wear a cloth face covering when you must be in public"

"There is <u>limited evidence</u> to suggest that use of cloth face coverings by the public during a pandemic could help reduce disease transmission."

And those "who feel comfortable wearing a mask should do so."

HSC Div 105, Part 1, Chapter 3, Section 120175.5 states that regarding the administration of communicable disease prevention and control:

"A local health officer must make any relevant information available to governmental entities."



Dear Supervisors Hall, Scofield, Miller, Hoek & Anderson:

I am writing to strongly oppose Item 37, the temporary Urgency Ordinance related to enforcement of COVID-related health department orders.

There are several grounds upon which this is at best a bad idea and at worst an unconstitutional power grab by the governor and health department, and thus by Nevada County.

- 1. The Governor's emergency power in March was triggered by a need to prevent overloading our urgent care capabilities. That risk has long passed, and under the CA Constitution the Governor's emergency power has ended. No such risk of overwhelming our care capacity currently exists. Accurate data support this conclusion.
- 2. As a result, the Governor's recent orders are illegal and unenforceable, as are the orders of our Health Department, which has no new emergency authority than the Governor's and which is inadequate to force such draconian measures. No emergency exists.
- 3. Substantial scientific evidence proves that wearing cloth face masks does not protect the wearer. COVID virus droplets, which to survive must be surrounded by a lipid (fat), can easily pass through the cotton mask cloth or simply pass around the mask periphery, as these are not sealed respirator-type masks.
- 4. Cotton mask proponents falsely argue that if someone is an asymptomatic carrier of the virus (no one has actually ever been identified as being one) and they breathe or sneeze, the virus will not escape the mask. Just as the virus can pass into the mask, it can pass out. So, they offer little to no protection to anyone.
- 5. Cotton masks are therefore useless to prevent the spread of the virus, and are nothing more than a "virtue signaling" ploy to self-proclaim as a "caring" individual. And a compliant member of the sheeple.




I am writing you as a resident in support of the proposed emergency ordinance to increase potential fines for businesses refusing to comply with safety measures in place to limit COVID19 transmission.

He even got a master's degree in nutrition and functional health as a result of his deep curiosity in the health of the human body. Now as a restaurant owner, he has installed a UV air scrubber on his HVAC system to kill any viruses in the air! What a marvelous piece of technology. All this to say, that my ex-husband is deeply invested in the health and safety of his family and customers.



Dear Supervisors Hall, Scofield, Miller, Hoek & Anderson:

I am writing to strongly oppose Item 37, the temporary Urgency Ordinance related to enforcement of COVID-related health department orders.

There are several grounds upon which this is at best a bad idea and at worst an unconstitutional power grab by the governor and health department, and thus by Nevada County.

- 1. The Governor's emergency power in March was triggered by a need to prevent overloading our urgent care capabilities. That risk has long passed, and under the CA Constitution the Governor's emergency power has ended. No such risk of overwhelming our care capacity currently exists. Accurate data support this conclusion.
- 2. As a result, the Governor's recent orders are illegal and unenforceable, as are the orders of our Health Department, which has no new emergency authority than the Governor's and which is inadequate to force such draconian measures. No emergency exists.
- 3. Substantial scientific evidence proves that wearing cloth face masks does not protect the wearer. COVID virus droplets, which to survive must be surrounded by a lipid (fat), can easily pass through the cotton mask cloth or simply pass around the mask periphery, as these are not sealed respirator-type masks.

Furthermore, masks do not protect your eyes. In fact, the exposed eye is the most easily infected part of the face! To actually protect the eyes, a person would need to wear tight fitting goggles


If you believe that face masks must be mandatory, then you must also believe that goggles to protect the eyes must be mandated!

- 4. Cotton mask proponents falsely argue that if someone is an asymptomatic carrier of the virus (no one has actually ever been identified as being one) and they breathe or sneeze, the virus will not escape the mask. Just as the virus can pass into the mask, it can pass out. So, they offer little to no protection to anyone.
- 5. Cotton masks are therefore useless to prevent the spread of the virus, and are nothing more than a "virtue signalling" ploy to self-proclaim as a "caring" individual.
- 6. Masks are not just merely a virtue symbol, they degrade the health of the wearer. Breathing one's CO2 and bacterialaden breath for long periods of time can actually cause health risks including degraded immunity capability--the exact opposite of what we as a society are striving for.
- 7. OSHA has strict regulations for PPE workplace use of masks and respirators to guard against these types of risks (CO2 toxicity and bacteria ingestion), but these actual "safety" regulations have been illegally ignored in the current mass application of masking in the business workplace setting.
- 8. We have adopted the draconian CCP practice of forcing everyone to wear an ineffective mask, AS IF EVERYONE IS INFECTED as a way to blindly force obedience to power-hungry officials. What is the miniscule percentage of actually infected people in our county? Less than one percent (-0.1%). Yet, we are all being treated as infected criminals, commanded to kill our local businesses and to kow-tow to our elected "representatives" who serve solely with our consent, who are forcing dangerous measures with NO scientific support.
- 9. When will this insanity end?
- 10. When will our Health Department enforce OSHA mask regulations to protect the health of workers and the public from excessive mask usage resulting in CO2 toxicity and bacteria overload? The argument that medical professionals suffer no adverse effects also is not supported. OSHA provides hospital and health professional that do wear masks for lengthy periods to be medically tested and extensive additional oxygen enhancing equipment provided.
- 11. When will our County Supervisors exercise appropriate control over staff and require independent investigation of legal, scientific and other appropriate considerations, as well as tailoring based upon local considerations?
- 12. PLEASE ACCEPT THIS AS NOTICE THAT Failure to vote no on Item 37 and continued use of force, under the color of law, upon individuals and businesses by county departments of these counter-scientific unwarranted un-Constitutional measures will most certainly expose the county and individuals therein to corporate and personal liability.

Dear Supervisors Hall, Scofield, Miller, Hoek & Anderson:

I am writing this letter out of concern for the health of our county. Our family stands in opposition to Item 37, the temporary Urgency Ordinance. I write this on behalf of my family of 5, our small family business, a restaurant, that supports the livelihoods of 8 people, and can also be representative of many friends and customers that we have spoken with at length on the subject. Covid-19 is not to be trifled with, and precautions should be taken to avoid unwanted and unnecessary spread (just as with any illness), however, I wish for the board to please consider that the damages to our quality of life and the health of our economy are now beginning to surpass the damages that Covid-19 has and will cause to the people of Nevada County, and the world.

From the onset of all of this, I have been closely monitoring the CDC website, and have acted in accordance with the guidelines provided to us by our local environmental health officers. I was standing strong with all the advice from Governor Newsom up until the latest order of July 13, 2020. My husband's business in now put in a position to either; ring a death knell for our business by following this order, or to stand up for ourselves, our lives, our beliefs, our quality of life, peace of mind and accept that this should not be a one size fits all approach to things. Everyone, every person, and every business is built differently and if you pay attention to what experts in the field of PPE are saying about masks, you would NEVER suggest a mandate of this nature. Governor Newsom himself had to come back after his initial mask mandate in order to include very important EXEMPTIONS. To ignore these exemptions is truly a health hazard.

#### In response to the fining of individuals not wearing a mask:

If you are to institute a fine for not wearing a mask, and I must be honest, I have not been able to read the verbiage of Item 37 yet, but I would be appalled to see anyone stopped in an outdoor location for not wearing a mask. I myself suffer from wearing a mask for a short while. I wear one in enclosed spaces where social distancing is not possible, but there is a price to pay. For me personally, even a simple trip to the grocery store means that I can expect a headache later in the day, acne breakout where there would not have been any (I know, not too big a deal), and a heightened level of anxiety, all due to wearing a mask.

The Governor, and now you, are asking that ALL children over the age of 2 wear a mask. So, if you see a four-year-old, walking with their masked mother, would you issue a fine? Enforcing this would be a tragedy. We certainly do not have data on the effects of mask wearing long term for children. We do however, have data that suggests that children are not very susceptible to covid-19 and we also now have data that shows that they are not the vectors for spread that we thought they were. The mask wearing by children should be ENTIRELY up to the children's parents. This is absolutely a governmental overreach. If there were severe cases in children and it was shown that they were causing massive spread, absolutely, masks, or better yet, keep them home. Please, please reconsider this punitive action.

#### In response to fining businesses not strictly adhering to the mask wearing:

I strongly believe that asking workers to wear them all day long in many situations is a bad idea. I think that if you choose to start fining businesses in this way, while it may look like a way to get some needed revenue for the county, you may lose it all later from law suits being filed against you. I hear story after story, from people I know locally, with 1-2 degrees of separation that people are passing out from wearing masks WHILE AT WORK. People need to be responsible, from every end of all of this. If you are sick, please stay the heck away from other people, inside, outside, doesn't matter. If you are not sick and want to stay that way, do what you personally need to do to ensure that.

Businesses have all sorts of things to contend with: levels of physical exertion, extreme heat of the California sun, open flame, the ability to communicate clearly over noise levels (I mean honestly, who hasn't experienced not being able to hear someone speaking through a mask?).

Indoor businesses are all designed differently. For the most part, many offices have disbanded to telecommute from home. For places needing to meet face to face with someone, this can be done outdoors, at length and for the most part, comfortably with mask on, but there are instances in which masks would be hazardous for the workplace and this has been recognized for us in restaurant with OSHA guidelines and we continue to follow these guidelines.

The real concern in the spread of the virus in shared, indoor spaces is the quality of the air. Our county, a smart county that wants to look out for the people and do the right things for peoples well being ought to recognize that there are tools at our disposal to combat the virus. It is true that we are still awaiting data on this in the specific case of the coronavirus, but the more we read, the more we see that the ultra violet light is effective in killing off covid-19. Our restaurant has installed this on our HVAC system. This method of removing Covid-19 particles from the air is in trial in many places and we await data to truly back it up, but as it is shown to be effective against other virus and bacteria particles, it is reasonable to think it is effective. These types of modifications need to be recognized.

It is my understanding that the virus will slow down considerably once we hit a sort of saturation point of infections. This may not be pleasant to think about, but one must be pragmatic rather than emotional about all of this. Please look into Michael Levitt and his calculations of "excess deaths".

If wearing a mask makes people feel safe, then good for them, they can keep wearing them. If instead it is causing panic attacks, anxiety, fainting, bacterial infections and more, I think the people with these experiences need to be given the choice of when, where and for how long they wear a mask.

I urge you to have faith in the people of Nevada County, and those who may be visiting or passing through, to be making the best choices for their health. We have had 1 singular death in our county thus far and while we may wish for it to stay that way, enforcing masks will not ensure that, it will only create even more contention over this issue.

For either, individuals and businesses, the only situation I can see where it would be okay to fine someone for not wearing a mask in public, or in an establishment, would be if they were specifically trying to infect someone with their germs. I sincerely hope this is not a problem here, but if it were, that person should be fined and possibly incarcerated.

The growth of the virus is not exponential. It is not going to wipe out a significant enough number of human lives to warrant the damages that have been made to the quality of our lives and our ability to provide an income. All of these businesses that are trying to survive are not to blame for any of this and without any financial assistance from the state, as a small business owner that cannot collect unemployment yet has to shoulder the burden if any of their employees do, are put in a most precarious position.



Dear Supervisors Hall, Scofield, Miller, Hoek & Anderson:

I am writing to strongly oppose Item 37, the temporary Urgency Ordinance related to enforcement of COVID-related health department orders.

There are several grounds upon which this is at best a bad idea and at worst an unconstitutional power grab by the governor and health department, and thus by Nevada County.

- 1. The Governor's emergency power in March was triggered by a need to prevent overloading our urgent care capabilities. That risk has long passed, and under the CAConstitution the Governor's emergency power has ended. No such risk of overwhelming our care capacity currently exists. Accurate data support this conclusion.
- 2. As a result, the Governor's recent orders are illegal and unenforceable, as are the orders of our Health Department, which has no new emergency authority than the

Governor's and which is inadequate to force such draconian measures. No such emergency exists.

- 3. Substantial scientific evidence proves that wearing cloth face masks does not protect the wearer. COVID virus droplets, which to survive must be surrounded by a lipid (fat), can easily pass through the cotton mask cloth or simply pass around the mask
- periphery, as these are not sealed respirator-type masks.
- 4. Cotton mask proponents falsely argue that if someone is an asymptomatic carrier of the virus (no one has actually ever been identified as being one) and they breathe or sneeze, the virus will not escape the mask. Just as the virus can pass into the mask, it can pass out. So, they offer little to no protection to anyone.
- 5. Cotton masks are therefore useless to prevent the spread of the virus, and are nothing more than virtue signaling ploy to self-proclaim as a caring individual.
- 6. Masks are not just merely a virtue symbol; they degrade the health of the wearer. Breathing ones CO2 and bacterialaden breath for long periods of time can actually cause health risks including degraded immunity capability--the exact opposite of what we as a society are striving for.
- 7. OSHA has strict regulations for PPE workplace use of masks and respirators toguard against these types of risks (CO2 toxicity and bacteria ingestion), but these actual "safety" regulations have been illegally ignored in the current mass application of
- masking in the business workplace setting.
- 8. We have adopted the draconian CCP practice of forcing everyone to wear an in effective mark. AS IT EVERYONE IS INTEGED as a way to blindly force chedions

ineffective mask, AS IF EVERYONE IS INFECTED as a way to blindly force obedience to power-hungry officials. What is the miniscule percentage of actually infected people in our county? Less than one percent (-0.1%). Yet, we are all being treated as infected criminals, commanded to kill our local businesses and to kow-tow to our elected

"representatives" who serve solely with our consent, who are forcing dangerous

measures with NO scientific support.

9. When will this insanity end?

- 10. When will our Health Department enforce OSHA mask regulations to protect the health of workers and the public from excessive mask usage resulting in CO2 toxicity and bacteria overload? The argument that medical professionals suffer no adverse effects also is not supported. OSHA provides hospital and health professional that do wear masks for lengthy periods to be medically tested and extensive additional oxygen enhancing equipment provided.
- 11. When will our County Supervisors exercise appropriate control over staff and require independent investigation of legal, scientific and other appropriate considerations, as well as tailoring based upon local considerations?
- 12. PLEASE ACCEPT THIS AS NOTICE THAT Failure to vote NO on Item 37 and continued use of force, under color of law, upon individuals and businesses by countydepartments of these counter-scientific unwarranted un-Constitutional measures willmost certainly expose the county and individuals therein to corporate and personal Liability. We will be holding you liable.
