



Snapshot of Behavioral Health Finances

FY23-24 Operating Budget \$51,390,778

Top 4 Revenue Sources:

- -Medi-Cal \$26M
- -Realignment \$9.7M
- -MHSA \$7.6M
- -Grants \$4.5M



Key Concept for Payment Reform

Paid for service provided versus paid back for certified costs incurred

- Still fee for service but not cost based reimbursement
- Moving towards capitation

Opportunities in this Change

- Ability to grow the system
- Chance to align our system with physical health care services
- Opportunity to capture the complete costs of serving a complex population
- Cost settlement audits go away



New Programming in FY 23/24

- Indigenous Outreach
- Senior Outreach
- Domestic Violence and Sexual Assault Advocacy program with focus on North San Juan area
- Homeless Youth Outreach and Case Management
- Community-based Youth Wellness Center in Truckee

Expanded Programming in FY 23/24

Expansions across most existing providers (average of 28%), including:

- Adult Full Service Partnership
 - > Increased slots
 - > Supported employment programming
 - > Increased support for emergency and permanent housing solutions
- Additional bed at Insight Respite Center
- Increased capacity through Stanford Sierra Youth and Families
- Expansion of Promotoras programming and staffing
- Expanded screening and case management services for mental health screening in high schools

Threats on the Horizon

MHSA Reform

- Shifts funds out of billable services and into housing costs that are not billable
- Every MHSA dollar cut from a billable program equates to a twodollar cut in services
- Addition of SUD only population with no new funds
- Focus on chronically homeless may equate to less housing for clients who do not meet that definition

Unknown Impacts of Payment Reform

Risk exacerbated by Electronic Health Record shift

Other new mandates with fiscal impacts

- Care Court
- Mobile Crisis Benefit
- BH-Connect waiver
- Many others . . .
