BACKGROUND:

The County of Nevada ("County"), on behalf of the Truckee-Donner Recreation & Park District ("District"), implements the Quimby Act pursuant to Section 17.01.030 of the Nevada County Code. The County Board approved the District's current Quimby Parkland Dedication Requirement on March 25th, 2014. The County adopted the current Quimby In-lieu fee for the District on August 13th, 2023. The Truckee-Donner Recreation & Park District prepared an updated "Quimby Land Dedication and In-Lieu Fee Study Update" in June 2025, which would revise the Quimby In-Lieu fees charged on new residential development pursuant to California Government Code Section 66477:

The Land Dedication amounts for new residential subdivisions based on the updated study would remain as follows:

Quimby in-lieu fees for new residential subdivisions based on the updated study would be amended as follows:

Single-Family Housing (County)	\$8,650 per unit	\$8,968 per unit
Multi-Family Housing (County)	\$7,570 per unit	\$7,849 per unit
