## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AMENDING RESOLUTION 21-178 DESIGNATING ARTS COLLABORATIVE OF NEVADA COUNTY DBA NEVADA COUNTY ARTS COUNCIL AS NEVADA COUNTY'S STATE-LOCAL PARTNER THROUGH THE CALIFORNIA ARTS COUNCIL STATE- LOCAL PARTNERSHIP PROGRAM IN PERPETUITY

WHEREAS, the California Arts Council (CAC) and the California State Legislature have established a State-Local Partnership program designed to empower local government and local arts and cultural agencies across the state to better meet the localized needs of the unique and diverse communities of California to serve the diverse cultural needs of California's local communities to encourage and promote art in education, to foster local and regional partnerships and collaboration, and to support local arts agencies that have been designated by local governments as partners; and

WHEREAS, the Nevada County Arts Council has served as Nevada County's local partner since 2009; and

WHEREAS, the Board of Supervisors adopted Resolution 21-178 on May 25, 2021, designating the Nevada County Arts Council as its local partner through the California Arts Council's (CAC's) State-Local Partner Program on an ongoing basis, to execute an annual scope of work as approved by the California Arts Council; and

WHEREAS, per CAC's request, the Nevada County Arts Council has requested the County to amend Resolution 21-178 to provide further clarity that Nevada County Arts Council shall be the local partner for the CAC State-Local Partnership Program in perpetuity, subject to annual reporting to Nevada County Board of Supervisors, to be eligible to receive CAC funding; and

WHEREAS, the Board's designation of the Nevada County Arts Council as a local partner does not require or imply the commitment of any County financial resources as a result of this designation.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada hereby amends Resolution 21-178 designating the Nevada County Arts Council as its local partner for the CAC State-Local Partnership Program in perpetuity, approves the submittal of ongoing annual applications by the Nevada County Arts Council to the CAC, and designates the Nevada County Arts Council to execute CAC's grants as approved by the California Arts Council.
