**BACKGROUND:**

At the beginning of each year, after the new Chair has been appointed, the Chair reviews and makes changes to the list of his or her appointments to various committees/commissions, including the delegates and alternates to the Rural County Representatives of California (RCRC), the Golden State Finance Authority (GSFA), the Golden State Connect Authority (GSCA), and the Rural Counties Environmental Services Joint Powers Authority (ESJPA).

The recommended appointments are discussed and acknowledged by the Board as one agenda item during a Board meeting. As of this writing, the committee/commission appointments have not been agendaized. However, RCRC will hold its first Board meeting on January 18, 2023 and has requested its member Counties confirm their delegates and alternates prior to that date.

Supervisor Sue Hoek has indicated her interest to serve as delegate for RCRC, GSFA, GSCA, and ESJPA, and Supervisor Hardy Bullock wishes to serve as alternate on RCRC, GSFA, and GSCA. David Garcia and Trisha Tillotson will be appointed as alternate one and alternate two for the ESJPA.

Therefore, we request the Chair select, and the Board ratify, Supervisor Sue Hoek to serve as delegate and Supervisor Hardy Bullock to serve as alternate to the Rural County Representatives of California, the Golden State Finance Authority, and Golden State Connect Authority, and Supervisor Sue Hoek to serve as delegate and David Garcia and Trisha Tillotson to serve as Alternates one and two respectively, on the Rural Counties Environmental Services Joint Powers Authority.
