SUBJECT: (Introduce and Waive Further Reading) An Ordinance amending and restating Title 15, Chapter 13, Section 15.13.250 of the Nevada County Code to make administrative updates pertaining to Solid Waste (Districts I-IV)

RECOMMENDATION: Introduce and waive further reading of the Ordinance.

FUNDING: There is no impact on the General Fund.

BACKGROUND: In 1978, Nevada County created County Service Area (CSA) 16 with Resolution 78-436 for the purpose of operating and maintaining the landfill and garbage collection in Western Nevada County. Resolution 79-292 was adopted in 1979, which established parcel charges for County Services Areas including CSA 16. In 1993, Ordinance 93-1832, expanded the parcel charges to all residents and businesses in Western Nevada County that benefit by being able to use the solid waste disposal system. Parcel charges are used to fund costs associated with the maintenance and improvements to the County's solid waste disposal system.

The County has the authority to collect solid waste fees under Government Code Section 25830 and Title 15, Chapter 13 of the Nevada County Code. In 1997, the Auditor-Controller's Office was directed, via Resolution 97-449, to consolidate activities from the various Western Solid Waste CSA funds into a single Western County Solid Waste Fund. This action redirected solid waste parcel charges, along with operating and improvement costs, from three separate funds into Fund 117 (now Fund 4117) to support proper accounting and reporting practices and to improve overall efficiency. Since that time, CSA 16 has been used primarily as a geographical boundary for the collection of solid waste fees in the western part of the County.

It is necessary to amend Title 15, Chapter 13 Section 15.13.250 of the Nevada County Code to replace CSA 16 (and the other county service areas and tax rate areas included within the geographical boundaries of CSA 16) with the new boundary legal description and the map; Exhibit A: legal description and B: boundaries map in Chapter 13 Section 15.13.250 Charges Established-Western Nevada County. With this administrative update, by replacing this section, we change how we describe our fee collection area to align with internal accounting practices. It has no impact on the currently adopted parcel charges. Since no new fees are proposed and no fee increases are proposed, there will be no need for any additional Prop 218 procedures.
