

**NEVADA COUNTY BOARD OF SUPERVISORS  
IS SEEKING INTERESTED PERSONS TO SERVE ON THE FOLLOWING:**

**\*ADULT AND FAMILY SERVICES COMMISSION:** (6 vacancies) Two Public Sector vacancies, both for 2-year terms ending April 30, 2021; Four Private Sector vacancies; two to fill 2-year unexpired terms ending April 30, 2019, and two to fill 2-year unexpired terms ending April 30, 2020. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human service's needs, and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. Private Sector members shall represent labor, business, or other private business, industry, labor, religious, human services, education, or other major groups and interests in the community. **\*AGRICULTURAL ADVISORY COMMISSION:** (1 position) One Forest & Related Industry representative to fill an unexpired 4-year term ending March 31, 2023. The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County, develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owner, and all others for wise conservation and management of resources to benefit the County's agricultural assets, and maintain an active Agricultural Commission to advise the County on agricultural-related matters. **\*AREA 4 AGENCY ON AGING ADVISORY COUNCIL:** (2 vacancies) Two Board of Supervisors appointed representatives, one to fill a 3-year term ending June 30, 2022 available June 30, 2019; and one Board to fill an unexpired 3-year term ending June 30, 2020. The Advisory Council shall advise the area agency on all matters relating to development and administration of the Area Plan and operations conducted thereunder. **\*ASSESSMENT APPEALS BOARD:** (1 vacancy) One alternate member to fill an unexpired 1-year term ending September 30, 2019. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. The functions of the Board are outlined in Section 1620 et seq. of the Revenue and Taxation Code. Compensated per Administrative Code Chapter II, Article 13.11. **\*BUILDING AND ACCESSIBILITY STANDARDS BOARD OF APPEALS:** (1 vacancy and 1 position) One Member-at-Large position available July 1, 2019 for a 4-year term ending July 1, 2023; and One member appointed by District IV Supervisor to be selected from the County at large, for a 4-year unexpired term ending July 1, 2020. This Board rules on appeals of discretionary orders, decisions or determinations made by the Building Official relative to the application and interpretation of the provisions of the technical codes. Two of the five members shall be physically handicapped persons who are qualified by experience and training to pass on matters pertaining to building construction, building service equipment and grading. The purpose will be to review and recommend proposed revisions and additions to the sewage disposal regulations or sewage disposal ordinance in an advisory capacity; review and recommend new methods, techniques, and materials for on-site sewage disposal, in an advisory capacity; and serve as an appeal body under the provisions of Section A-032 of County Resolution 98-217.
