**BACKGROUND:**

Currently there are 7 vacancies and 3 positions on the Nevada County Sanitation District No. 1; one Lake Wildwood Zone 1 alternate, one Cascade Shores Zone 8 representative, one Cascade Shores Zone 8 alternate, and one Eden Ranch Zone 9 representative, one Lake Wildwood Zone 1 position, one Lake of the Pines Zone 2 position and one alternate, one North San Juan Zone 4 representative and one Gold Creek Zone 5 representative, and one Penn Valley Zone 6 representative. These positions were advertised and posted on the Board of Supervisors Chambers Bulletin Board, in the Board of Supervisors Office, at the Madelyn Helling Library, and on the County website. Notice was also posted at Grass Valley Library, Truckee Library, Truckee Joseph Center, the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Mr. Dennis Chipchase and Mr. Edward Wydra have submitted applications to be reappointed to the Nevada County Sanitation District No. 1 Advisory Committee. No other applications were received. Mr. Chipchase has served on the Committee since November 9, 2004; Mr. Wydra has served on the Committee since June 8, 2010. These reappointments are recommended by the Nevada County Sanitation District No. 1 Advisory Committee.

Please consider reappointing Mr. Dennis Chipchase and Mr. Edward Wydra to the Nevada County Sanitation District No. 1 Advisory Committee for terms expiring June 30, 2018.
