BACKGROUND:

Currently, there are six vacancies and four positions for the Adult and Family Services Commission. Vacancies and positions included two vacancies for Public Sector and two vacancies for Private Sector representatives for two-year terms beginning May 1, 2025, and ending April 30, 2027, one vacancy for Private Sector and one vacancy for Public Sector for unexpired two-year terms ending April 30, 2026, and three positions for Low-Income Sector representatives and one position for a Public Sector representative beginning May 1, 2025, and ending April 30, 2027. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.
