RESOLUTION APPROVING CONTRACT AMENDMENT 2 WITH WEST COAST ARBORISTS, INC. FOR TREE TRIMMING AND REMOVAL SERVICES

WHEREAS, the Nevada County Board of Supervisors (Board) approved Resolution 17-529 approving a contract with West Coast Arborists, Inc. (WCA) for tree trimming and removal services with the ability to execute four (4) additional annual renewals beginning July 1, 2019; and

WHEREAS, the Board approved Resolution 19-281 approving Amendment No. 1 to the contract for \$150,000 effective July 1, 2019 through June 30, 2020; and

WHEREAS, Exhibit B: Schedule of Charges and Payments of the agreement needs to be updated to allow for increases in the California Department of Industrial Relations pre-determined wages.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves Amendment 2 to the contract, attached as Exhibit A , and authorizes the Chair of the Board of Supervisors to execute the Amendment between the County of Nevada and WCA for tree trimming and removal services.

AMENDMENT 2 TO CONTRACT WITH WEST COAST ARBORISTS, INC.

THIS AMENDMENT is executed this 9th day of July, 2019 by and between West Coast Arborists, Inc. and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Tree Trimming and Removal Services executed on October 20, 2017 by Resolution No. 17-529 and which Agreement was subsequently amended on June 18, 2019 by Resolution No. 19-281.

WHEREAS, the parties desire to amend their agreement to allow or provide for an update to Exhibit B: Schedule of Charges and Payments in order to comply with increases in the California Department of Industrial Relations pre-determined wages.
