Following up on my previous emails (see below) I wanted to point out that the Public Records Act request still remain unfulfilled. The 10 days recommended by state law has now passed and I would appreciate an update.

Questions for today's Board of Supervisors meeting:

1. Are the total numbers being compiled on your Coronavirus Dashboard including people who have tested "positive" for COVID-19 but are no longer symptomatic? Are these being listed as "new cases"?
2. Why aren't you adding perspective on the Dashboard? For instance, Nevada County has 1 death total. That comes to 1 death per 100K. California in comparison is at 6 deaths per 100K. Nevada County has 78 TOTAL cases (78 per 100K) reported but the state has 118 per 100K in just the past 14 days. Considering the hysteria that is being spread by certain members of the community perspective could prove invaluable.
3. What is the County's ICU capacity? Where does that number stand currently as it pertains to COVID-19? Why isn't this information posted on the Dashboard?

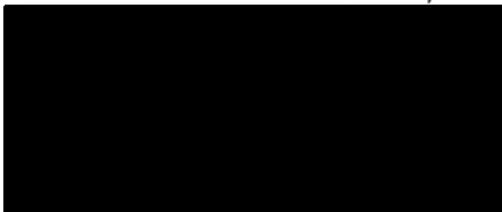
