

AMENDMENT #2 TO PERSONAL SERVICES CONTRACT

This **Amendment #2** ("Amendment") takes effect as of the date signed by all parties listed in this preamble ("Effective Date"), and amends and revises that certain **Personal Services Contract**, dated June 1, 2019, as amended from time to time (the "Agreement"), by and between **Telmate, LLC** with an address of 3120 Fairview Park Drive, Suite 300, Falls Church, Virginia 22042 (the "Contractor"), and **County of Nevada**, with an address of 950 Maidu Avenue, Nevada City, California 95959-8600 (the "County") (Contractor and County collectively, the "Parties" and each a "Party"). All capitalized terms not defined herein shall have the definitions set forth in the Agreement.

WHEREAS, the Parties have agreed to amend the Agreement, as further described below;
and



Except as set forth in this Amendment, the Agreement remains in full force and effect, without modification or amendment, and is hereby ratified and confirmed. This Amendment may be executed in multiple counterparts, each of which shall be an original, and all of which shall be one and the same contract.
