RESOLUTION TO RESCIND ASSET NUMBER 26561 FROM A SURPLUS STATUS AND APPROVE TRANSFER OF THE ASSET/VACTOR TRUCK FROM NEVADA COUNTY SANITATION DISTRICT NO. 1 TO FLEET ROADS EQUIPMENT FUND (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Sections 25504 and 25365 of the California Government Code authorize the Board of Supervisors to establish regulations whereby the County Purchasing Agent may, by direct sale or otherwise, sell or dispose of any personal property belonging to the County of Nevada not being required for public use, and

WHEREAS, the Board of Supervisors has adopted the Purchasing Policy and provided regulations for the disposal of surplus county personal property; and

WHEREAS, on August 24, 2021, the Board of Supervisors approved Resolution 21-384 to surplus Asset Number 26561, a Sterling L8500 Vactor Truck, that was no longer being utilized by the Nevada County Sanitation District No. 1 (NCSD) with a 4/5 majority required vote; and

WHEREAS, the Public Works Roads Maintenance Division is in need of a Vactor Truck to clean culverts, ditches and potholes as their current flush truck and street sweeper are deficient at effectively completing these maintenance tasks; and

WHEREAS, the Vactor Truck has not been sold, donated, or disposed of since becoming a surplus asset and the NCSD desires to transfer this asset to Fleet Road Equipment Fund at no cost.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Rescinds Asset Number 26561 from surplus status and transfers it back to the NCSD; and
- 2. Approves the asset transfer from the NCSD to Fleet Road Equipment Fund at no cost per SR 24-0098; and
- 3. Directs the Auditor Controller to record the transfer of Asset Number 26561 from account 4700-91005-709-1000 to 4292-92007-704-3000.
