WHEREAS, funding for the changes is included in the various departmental budgets for Fiscal Year 2022/23; and

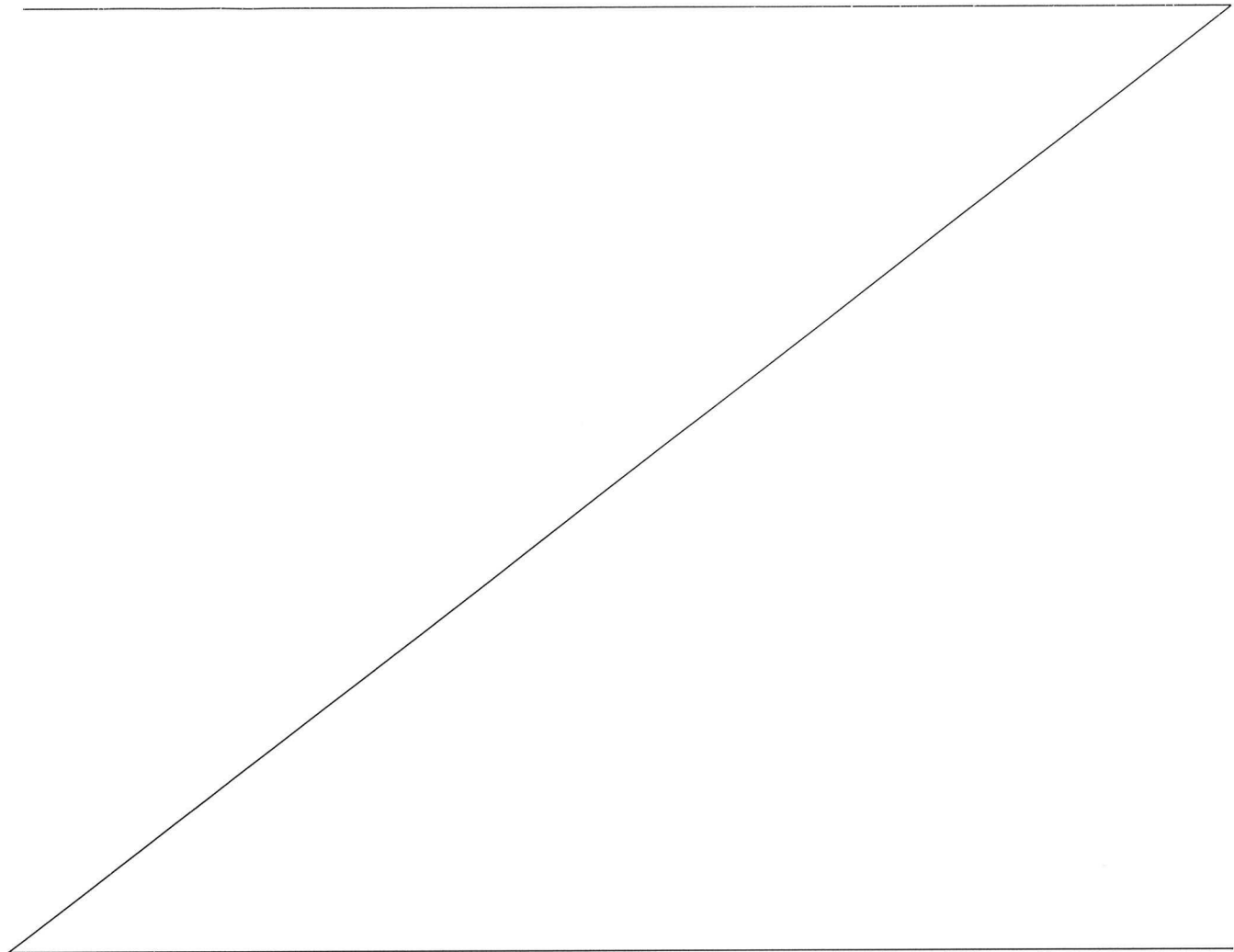
WHEREAS, bargaining units were met and conferred with as needed.
