## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE APPLICATION FOR AND RECEIPT OF NO PLACE LIKE HOME (NPLH) TECHNICAL ASSISTANCE GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT AND AUTHORIZE RICHARD A. HAFFEY, COUNTY EXECUTIVE OFFICER, TO SIGN THE GRANT APPLICATION

WHEREAS, the State of California, Department of Housing and Community Development (HCD) has issued a Notice of Funding Availability (NOFA) dated April 10, 2017 for its No Place Like Home (NPLH) Program Technical Assistance Grants; and

WHEREAS, Nevada County desires to submit a project application for the NPLH Program and will submit a 2017 Technical Assistance Grant Application as described in the NPLH Program Technical Assistance Grants NOFA and NPLH Program Technical Assistance Grant Guidelines released by HCD for the NPLH Program; and

WHEREAS, HCD is authorized to provide up to \$6.2 million from the Mental Health Services Act Fund for technical assistance and application preparation assistance to Counties (as described in Welfare and Institutions Code §5849.10) related to the NPLH Program; and

WHEREAS, the Nevada County Behavioral Health Department seeks approval to apply for the NPLH Program Technical Assistance Grant in the amount of \$75,000, which is the maximum award for small counties (population less than 200,000); and

WHEREAS, upon a successful application for the NPLH Technical Assistance Grant submitted by the Nevada County Behavioral Health Department, a Standard Agreement will be issued by HCD and brought before the Board of Supervisors for approval.

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA RESOLVES AS FOLLOWS:

- 1) The County is hereby approved to apply for and submit to HCD the 2017 NPLH Program Technical Assistance Grant Application released April 10, 2017 in the amount of \$75,000
- 2) In connection with the NPLH Program Technical Assistance Grant, if the application is approved by HCD, the County is authorized to enter into, execute, and deliver a State of California Standard Agreement in the amount of \$75,000, and any and all other documents required or deemed necessary or appropriate to evidence and secure the NPLH Program Technical Assistance Grant, the County's obligations related thereto, and all amendments thereto (collectively, the "NPLH Technical Assistance Grant Documents")

- 3) The County shall be subject to the terms and conditions as specified in the Standard Agreement, the NPLH Program Technical Assistance Guidelines, the NPLH statute (Welfare and Institutions Code §5849.1 et. Seq.), and any applicable NPLH Program guidelines published by HCD. Funds are to be used for allowable project expenditures as specifically identified in the Standard Agreement. The application in full is incorporated as part of the Standard Agreement. Any and all activities funded, information provided, and timelines represented in the application will be enforceable through the executed Standard Agreement. The County hereby agrees to use the funds for eligible uses in the manner presented in the application as approved by HCD and in accordance with the NPLH Program Technical Assistance Grant NOFA, the NPLH Program Technical Assistance Guidelines, and 2017 NPLH Program Technical Assistance Grant Application.
- 4) Richard A. Haffey, County Executive Officer, is authorized to sign the County of Nevada NPLH Program Technical Assistance Grant Application, the NPLH Program Technical Assistance Grant Documents, and any amendments thereto, on behalf of the County as required by HCD for receipt of the NPLH Program Technical Assistance Grant.
