**SUBJECT:** Resolution to Approve Bidding Documents for the 2022 Road Rehabilitation Project 450010, and authorizing the Purchasing Agent to solicit bids, and authorizing the Director of Public Works to award and execute the contract to the lowest responsive bidder (not to exceed \$1,389,300) or to reject all bids; and authorizing the Auditor to amend necessary budgets and encumber the contract — Districts II, IV

**RECOMMENDATION:** Approve the attached Resolution to allow advertising of the Bidding Documents, Specifications, and Contract Documents for the 2022 Road Rehabilitation Project.

**FUNDING:** This project will be funded with Road Maintenance and Rehabilitation Account (RMRA) funds, and funds from County Service Area (CSA) 38 Zone 2 and CSA 1 Zone 1, there is no impact to the General Fund. The project is included in the FY 2022/23 Capital Improvement Program for Road Engineering. An amendment for FY 2021/22 is required in all three funds to award and encumber the full contract in FY 2021/22.

**BACKGROUND:** On February 8, 2022, the Nevada County Board of Supervisors approved an environmental clearance for pavement rehabilitation along multiple county-maintained roads and two County Service Area (CSA) locations.

The Department of Public Works is proposing to rehabilitate approximately 4.4 miles of roadway using a combination of asphalt repairs, and resurfacing as shown on Attachment A. The Director of Public Works may make adjustments to the roadways listed as necessary.

The project plans, specifications, and cost estimate for this project have been completed. The engineer's estimate is \$1,263,000, plus a 10% contingency of \$126,300 for a total not to exceed contract of \$1,389,300.

The bid opening date will be set by the Director of Public Works, with construction scheduled to begin in summer 2022. If the lowest responsive and responsible bid exceeds the engineer's estimate, staff will either bring this item back to the board for approval or reject all bids.
