



# RESOLUTION No. 19-212

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING AMENDMENT NUMBER 1 TO THE AGREEMENT PESM3609 BETWEEN THE COUNTY OF NEVADA AND WINNER CHEVROLET FOR THE AUTO REPAIR AND BODY REPAIR OF VEHICLES FOR NEVADA COUNTY FLEET SERVICES INCREASING THE AMOUNT OF THE CONTRACT TO A NEW MAXIMUM AMOUNT NOT TO EXCEED \$35,000, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT AMENDMENT

WHEREAS, in July 2018, the Nevada County Purchasing Agent executed a service contract PESM3609 between Nevada County and Winner Chevrolet for auto repair and body repair of County vehicles which is effective July 1, 2018 and will expire on June 30, 2019; and

WHEREAS, the original contract amount for \$25,000 is being increased to a total contract amount not to exceed \$35,000 to cover costs of additional unexpected repairs; and

WHEREAS, these repairs exceeded the original estimated maintenance and repair budget. The repair costs will be a direct reimbursement from departments whose assigned vehicles required auto body repairs due to vehicle accidents; and

WHEREAS, there is sufficient budget in the Fiscal Year 18/19 Fleet Services Budget 4291-92005-704-2000/520900.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors, on behalf of the County of Nevada, approves the contract amendment with Winner Chevrolet, increasing the maximum contract amount to a new amount not to exceed \$35,000 and authorizes the Chair of the Board to execute the amendment.

**AMENDMENT #1 TO PERSONAL SERVICES AGREEMENT PESM3609  
WITH WINNER CHEVROLET**

**THIS AMENDMENT** is executed this 28th day of May 2019 by and between Winner Chevrolet and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement PESM3609 between the parties entitled Personal Services Contract for Auto and Body Repair for Nevada County Fleet Services executed on July 1, 2018 by the Purchasing Director.

**WHEREAS**, the County has encountered the need for unexpected repairs of County vehicles which were not contemplated in the original Agreement, and,


**WHEREAS**, the parties now desire to increase the Maximum Contract Amount to cover the cost of providing these additional services; and,

**WHEREAS**, the original contract was executed by the Purchasing Agent and the proposed amendment will exceed the purchasing agent's signing authority.

**NOW, THEREFORE**, the parties hereto agree as follows:

1. This amendment shall be effective as of May 28, 2019.
2. That Section 2 of the Agreement, Maximum Contract Price, is hereby increased by \$10,000, for a total Maximum Contract Price of \$35,000;
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
