SUBJECT: Reappointments to the Local Planning Council for Child Care Development for the County of Nevada

RECOMMENDATION: Approve the reappointments of Justine Riley as Public Agency representative, Anne Wolf as Discretionary Member, and Carolyn Tate as Child Care Provider Member to the Local Planning Council for Child Care Development for the County of Nevada, for two-year terms ending June 30, 2028.

BACKGROUND:

Currently, there are five positions available on the Local Planning Council for Child Care Development for the County of Nevada. One Child Care Provider, one Community Member, one Consumer Member, one Discretionary Member and one Chair of the Board of Supervisors Public Agency representative, all to fill two-year terms beginning July 1, 2026, and ending June 30, 2028. The purpose of this council shall be to identify childcare and development services' priorities to enhance cooperation among children's services, interest groups and agencies, develop a strategic long-range plan for a broad spectrum of childcare and development services, and advocate for the support of childcare and development services at the local, state, and federal levels of government. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Justine Riley submitted an application for reappointment on May 26, 2026. She has served on the Council since September 13, 2016, and is a member in good standing.

Anne Wolf submitted an application for reappointment on June 3, 2026. She has served on the Council since August 11, 2015, and is a member in good standing.

Carolyn Tate submitted an application for reappointment on June 19, 2026. She has served on the Council since July 1, 2009, and is a member in good standing.
