## **SCOPE OF WORK**

### **Traffic Signal Maintenance Annual Contract**

#### **1.0 GENERAL**

Contractor shall furnish all labor, supervision, tools, materials, equipment, transportation, and services to maintain all traffic signals and related equipment as described in this Bid, in good working order for Placer County (hereinafter "County").

The successful bidder agrees to extend applicable maintenance pricing, on-call hourly rates and materials markup in this bid to the City of Auburn. Any contract resulting from this requirement shall be executed by the City of Auburn and the successful bidder. Placer County will not be a party to "other agency" contracts.

All work shall be performed by trained and qualified personnel in accordance with the Scope of Work contained herein. All parts and materials installed by the Contractor shall be new and unused.

#### **2.0 PREVENTIVE MAINTENANCE**

The Contractor shall provide a continuous and comprehensive preventive maintenance program designed to minimize the incidence of outages and malfunctions, reduce complaints, and extend the useful life of all traffic signal equipment. Contractor shall perform the preventive maintenance tasks listed below.

##### **2.1 MONTHLY PREVENTIVE MAINTENANCE**

- 2.1.1 Visually inspect controller for proper operation. Examine the way it functions in relation to the traffic. Correct functional problems as soon as possible and report functional and timing problems to the County. Report discrepancies between traffic signal timing sheet and traffic signal timing programmed into traffic signal controller to County Engineer.
- 2.1.2 Visually inspect all vehicular and pedestrian signals for proper operation. Walk each intersection and observe for proper operation, alignment, broken lenses, and missing parts. Depress all pedestrian push buttons and observe the timing, operation, and display. Correct all observed problems as soon as possible thereafter.
- 2.1.3 Observe and check for proper operation of the detector loops and amplifiers. Adjust or re-tune detector amplifiers and correct sub-standard splices as necessary. Report improper loop operations and causes to the County.
- 2.1.4 Make routine adjustment, calibrations, and minor repairs.

- 2.1.5 Manually record inspection date and time in controller cabinet and send written confirmation of monthly inspection to the County with recommendations by intersection within the respective jurisdiction.
- 2.1.6 Observe and check Opticom Emergency Vehicle system for proper operation. Adjust equipment and correct substandard connections or splices as necessary. Report improper operations and causes to the County.
- 2.1.7 Observe and check Battery Backup System for proper operation. Adjust equipment and correct substandard connections as necessary. Report improper operations and causes to the County.

## **2.2 SIX-MONTH PREVENTIVE MAINTENANCE**

- 2.2.1 Check and adjust fan operation. Check the filter for tight fit and tape if required. Clean and vacuum the cabinet as necessary. Examine cabinet interior for water, excessive dampness, and plant or animal intrusion. Determine cause and correct the condition as necessary.
- 2.2.2 Inspect all relays, switches, terminals, ground rod clamps, wires, etc. and replace or make adjustments or minor repairs as necessary. Make arrangements to promptly repair those deficiencies which cannot be corrected immediately.
- 2.2.3 Check and maintain operation of ground fault receptacle.
- 2.2.4 Measure and maintain voltage at service inputs in cabinet and record.
- 2.2.5 Visually check and maintain integrity of splices and connections.
- 2.2.6 Visually check and maintain for wear and function on electromechanical controllers.
- 2.2.7 Check and maintain the time setting and match with time sheet on electromechanical and solid state controllers.
- 2.2.8 Manually record inspection date and time in controller cabinet and send written confirmation of 6-month inspection to the County with recommendations by intersection within the respective jurisdiction.
- 2.2.9 Include all work performed during monthly preventive maintenance.

## **2.3 ANNUAL PREVENTIVE MAINTENANCE**

- 2.3.1 Clean and polish all lenses and reflectors.
- 2.3.2 Vacuum and clean controller cabinet and contents.
- 2.3.3 Replace cabinet filter.

- 2.3.4 Check and replace as needed the weatherproof gasket seal on controller cabinets.
- 2.3.5 Check for water accumulation and duct sealant. Clean and replace sealant as needed.
- 2.3.6 Lubricate hinges and lock on controller cabinets.
- 2.3.7 Check and maintain alignment of all signal heads.
- 2.3.8 Check and maintain indicator lamps.
- 2.3.9 Check and maintain all connectors.
- 2.3.10 Check and maintain detector extensions.
- 2.3.11 Check and maintain load switches.
- 2.3.12 Check and maintain relays.
- 2.3.13 Replace flashing beacon lamps.
- 2.3.14 Manually record inspection date and time in controller cabinet and send written confirmation of yearly inspection to the County with recommendations by intersection within the respective jurisdiction.
- 2.3.15 Traffic Signal Monitors shall be shop or field tested for proper operation at least once every 12 months. Monitor testers shall be shop certified by qualified personnel, as recommended by the manufacturer at least every 12 months.
- 2.3.16 Include all work performed during monthly and six-month preventive maintenance.

## **2.4 COMPENSATION FOR PREVENTIVE MAINTENANCE**

Compensation for preventive maintenance work shall be paid for in accordance with the Maintenance Price Schedule and materials markup indicated in the Contractor's bid response.

## **3.0 EMERGENCY REPAIRS**

- 3.1 Emergency repairs require the Contractor to respond within 1 hour. Emergency repairs include, but are not limited to, signals and safety lighting damaged due to accidents, vandalism, acts of God, or pavement failure. The work may include cleanup of debris, erection of necessary warning and safety devices, and hookup of a temporary signal or controller. Permanent repairs shall be completed in less than 30 days, unless approved otherwise by the County.
- 3.2 Emergency repair services shall be provided on a 24 hours per day, 7 days per week basis.

- 3.3 Each response shall be billed on a separate invoice with a complete description of work performed, location, and date completed.
- 3.4 Compensation for emergency repair work shall be paid for in accordance with the On-Call Hourly Rate Schedule and materials markup indicated in the Contractor's bid response.

#### **4.0 NORMAL REPAIRS**

- 4.1 The Contractor shall investigate and determine the corrective requirements for each reported malfunction, failure, or outage of a traffic signal system. The Contractor shall repair or replace equipment and components that have failed, deteriorated, or malfunctioned from the normal operation of the traffic signal system. Normal repairs may include, but not be limited to, the following elements:
  - Incandescent lamps, 3M type programmed visibility (PV) lamps, conflict monitors, load switches, detector amplifiers, transfer switches, flasher switches, breaker switches, ballasts, starters, sockets, fuses, fuse holders, signal, and safety light wiring in poles.
- 4.2 Normal repair services shall be provided on a 24 hours per day, 7 days per week basis.
- 4.3 Each response shall be billed on a separate invoice with a complete description of work performed, location, and date completed.
- 4.4 Compensation for normal repair work shall be paid for in accordance with the On-Call Hourly Rate Schedule and materials markup indicated in the Contractor's bid response.

#### **5.0 ADDITIONAL WORK**

Compensation for additional repair work shall be paid for in accordance with the On-Call Hourly Rate Schedule and materials markup indicated in the Contractor's bid response.

#### **6.0 SALVAGED EQUIPMENT**

The Contractor shall deliver any salvaged/salvageable equipment or materials to the County. Any equipment or material declared non-salvageable by the County shall be legally disposed of by the Contractor.

#### **7.0 ADDITIONAL REQUIREMENTS**

- 7.1 All work shall be performed in accordance with the requirements of the California Department of Transportation, the National Electric Code, the California Department of Industrial Relations, the Division of Industrial Safety, and the California Public Utilities Commission.
- 7.2 Contractor shall perform all work under this Contract as an independent contractor, subject to inspection and approval by the County.



- 7.3 Contractor shall provide phone and cell numbers for receiving repair or service requests 24 hours a day, 7 days a week.
- 7.4 Contractor shall have service personnel available 24 hours a day, 7 days a week to respond to traffic signal and controller trouble calls. In the event of multiple service requests from the County, each request will be serviced on a priority basis as determined by the County.
- 7.5 Failure to respond in a timely manner shall be sufficient cause for the County to authorize repairs to be completed by others and deduct the costs of said repairs from payments due to the Contractor. Repeated failure to respond in a timely manner shall be deemed sufficient cause to terminate the Contract.

## **8.0 INVOICING**

Contractor shall submit itemized invoices to the County containing at minimum: locations, description of work performed, description of equipment and/or components installed, quantities, unit prices, hourly rates and extended prices. Contractor shall provide invoices with sufficient information such that the County is able to verify that contract pricing is being properly billed. County shall pay invoices on a net 30 basis.

The successful bidder(s) shall furnish evidence of insurance, including required endorsements, to Placer County Procurement Services demonstrating proof of coverage in the amounts as specified in **Attachment C, Placer County Insurance Requirements**, within ten (10) calendar days following receipt of a Notice of Intent to Award.

THE PROOF OF INSURANCE SHALL INCLUDE A SEPARATE ENDORSEMENT FORM(S) CONTAINING THE EXACT ENDORSEMENT LANGUAGE SPECIFIED IN SECTION 5.0 OF THE ATTACHED INSURANCE REQUIREMENTS, AND SHALL INCLUDE THE GENERAL LIABILITY POLICY NUMBER. BLANKET ENDORSEMENT FORMS MAY BE REJECTED.

Failure to comply with the County's insurance and endorsement requirements will result in the disqualification of your bid. All costs of complying with the insurance AND endorsement requirements shall be included in your pricing. Bidders are strongly advised to read **Attachment C - Placer County Insurance Requirements**, prior to submitting a price quote. Bidders are NOT required to submit proof of insurance with their bid.

**2. PREVAILING WAGE REQUIREMENTS**

The Work described in this Price Quote is subject to the payment of not less than prevailing wages under Labor Code Section 1770 et seq. Bidders are hereby notified that the Director of Industrial Relations has ascertained the general prevailing rate of per diem wages and the rates for overtime and holiday work in the locality in which the work is to be performed for each craft, classification or type of worker needed to perform the Work under the contract which will be awarded to the successful bidder. Copies are on file with and available upon request from the Department of Facilities Management or at <http://www.dir.ca.gov/dlsr/DPreWageDetermination.htm>. Bidders are further notified that this project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Further information on Compliance Monitoring Unit requirements can be found at <https://www.dir.ca.gov/dlse/cmu/cmu.html>.

No contractor or subcontractor may be listed on a bid proposal for a public works project submitted on or after March 1, 2015 unless registered with the Department of Industrial Relations pursuant to Labor Code Section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code Section 1771.1(a).

No contractor or subcontractor may be awarded a contract for public work on a public works project awarded on or after April 1, 2015 unless registered with the Department of Industrial relations pursuant to Labor Code Section 1725.5.

Contractor agrees to comply with all related provisions of the Labor Code, including but not limited to, the provisions of Labor Code Section 1775 relating to the payment of prevailing wages, Section 1777.5 relating to the employment of apprentices and Section 1811-1813 relating to the payment of Overtime. Failure to comply with the proper prevailing wage requirements may result in a penalty of up to \$200 per day per worker. Failure to comply with

apprenticeship requirements may result in a penalty of \$100-\$300 for each calendar day of violation. Failure to pay proper overtime rate may result in a penalty of \$25 per day per worker.

The County will not recognize or be liable for any claims for additional compensation because of the payment of the wages set forth in the Contract Documents or Contractor's failure to pay prevailing wages. The possibility of wage increases is one of the elements to be considered by the Contractor in determining its proposal, and will not under any circumstances be considered as the basis of a claim against the County or the Project Managers. Any cost associated with the submission of electronic certified payroll and related documentation to the County or the State are also to be included in the contractor's price quote price and no change order will be granted for any costs incurred by the contractor.

### **3. TRAVEL AND SUBSISTENCE PAYMENT**

The Contractor's attention is directed to Section 1773.8 of the Labor Code, which requires the payment of travel and subsistence payments to each worker needed to execute the work, as those payments are defined in collective bargaining agreements filed with the Department of Industrial Relations.

### **4. EIGHT-HOUR DAY LIMITATION**

In accordance with the provisions of the Labor Code, and in particular, Sections 1810 to 1815 thereof, inclusive, eight hours labor shall constitute a day's work, and no worker, in the employ of said Contractor, or any Subcontractor, doing or contracting to do any part of the work contemplated by this Contract, shall be required or permitted to work more than eight (8) hours in any one calendar day and forty (40) hours in any one calendar week in violation of those provisions; provided that subject to Labor Code Section 1815, a worker may perform work in excess of either eight (8) hours per day or forty (40) hours during any one week upon compensation for all hours worked in excess of eight (8) hours per day or forty (40) hours during any one week at not less than one and one-half times the basic rate of pay.

The Contractor and each Subcontractor shall also keep an accurate record showing the names, addresses, social security numbers, work classifications, straight time and overtime hours worked each day and week, and the actual per diem wages paid to each journeyman, apprentice, worker, or other employee employed by the Contractor and by the Subcontractor in connection with the work specified herein, which record shall be open at all reasonable hours to the inspection of the County, State and Federal officers and agents; and it is hereby further agreed that, except as provided above, the Contractor shall forfeit as a penalty to the County the sum of twenty-five dollars (\$25) for each worker employed in the performance of this Contract by it or by any Subcontractor under it for each calendar day during which such worker is required or permitted to labor more than eight (8) hours in any one calendar day and forty (40) hours in any one calendar week in violation of Labor Code Sections 1810 through 1815.

### **5. COMPLIANCE WITH STATE REQUIREMENTS FOR EMPLOYMENT OF APPRENTICES**

The Contractor's attention is directed to Section 1777.5 and 1777.7 of the Labor Code; provisions of those Sections pertaining to employment of registered apprentices are hereby incorporated by reference into these Specifications. As applicable, the Contractor or any Subcontractor employed by it in the performance of the Contract work shall take such actions as necessary to comply with the provisions of Section 1777.5.

**6. SUBCONTRACTING**

The successful bidder shall not subcontract any portion of the work to be performed under the resulting agreement without prior approval from the County department. In the event that the County has approved the use of a subcontractor, the County will work with the successful bidder as the Prime Contractor. Under no circumstances will the County be required to deal directly with a subcontractor. If a subcontractor is utilized, the successful bidder shall invoice the County at the agreed upon rates listed in the bidder's response to this price quote.

**7. SAFETY**

The Contractor shall be solely and completely responsible for the conditions of the job site, including safety of all persons and property during performance of the work. This requirement shall apply continuously and not be limited to normal working hours. Safety provisions shall conform to all applicable Federal, State, and local laws, ordinances, and codes, and to the rules and regulations established by the State Division of Industrial Safety, and to other rules of law applicable to the work. All work and materials shall be in strict accordance with all applicable State, Federal and local laws, rules, regulations, and codes.

**8. PROTECTION OF PERSONS AND PROPERTY**

The successful bidder (hereinafter "Contractor") shall exercise precaution at all times for the protection of persons and property, including the County's employees, the general public, property and its own employees. The Contractor shall comply with all federal, state and local laws, regulations, statutes and ordinances relative to the execution of the services described herein. This requirement includes, but is not limited to, applicable regulations concerning employment of labor, public and employee safety and health, and similar subjects. The Contractor shall be responsible for its employees' safety and training requirements mandated by Cal-OSHA.

**9. WORKMANSHIP**

All services shall be performed in accordance with the highest standards prevailing in the trades. All of the successful bidder's employees shall be especially skilled and appropriately trained and certified for the kind of work for which they are employed. Should the successful bidder's Manager and/or Placer County staff deem anyone employed by the successful bidder incapable of completing the work required, the successful bidder shall immediately dismiss the employee from performing services on behalf of the County. Such removal shall not be considered a basis for employee's claim for compensation or damages against the County, or any of its officers or agents.

**10. SERVICE STANDARDS**

The successful bidder shall provide all necessary personnel, tools, parts, materials, and equipment to perform the services described herein. The successful bidder shall perform all work in such a manner as to meet all accepted standards for safe practices for overhead door maintenance and repair services and to safely maintain stored equipment or other hazards consequential or related to the work. The successful bidder agrees to accept the sole responsibility for complying with all local, County, State or other legal requirements at all times including, but not limited to, O.S.H.A. and CAL. O.S.H.A. Safety Orders. The successful bidder must meet all EPA standards as well as all Federal, State, and Local laws, standards, and regulatory and permitting requirements while performing services on behalf of Placer County.

During performance and upon completion of services the successful bidder shall remove all unused equipment, supplies, instruments of service, all excess or hazardous material, trash, and legally dispose of them.

## **11. COUNTY'S RIGHT TO AUDIT AND PRESERVATION OF RECORDS**

**11.1** The Contractor shall maintain books, records and accounts of all costs in accordance with generally accepted accounting principles and practices. The County and its authorized representatives shall have the right to audit the books, records and accounts of the Contractor under any of the following conditions:

- a) The Contract is terminated for any reason in accordance with the provisions of the Contract Documents in order to arrive at equitable termination costs;
- b) In the event of a disagreement between the Contractor and the County over the amount due the Contractor under the terms of the contract;
- c) To check or substantiate any amounts invoiced or paid which are required to reflect the costs of the Contractor, or the Contractor's efficiency or effectiveness under this Contract or in connection with extras, changes, claims, additions, backcharges, or others, as may be provided for in this contract;
- d) If it becomes necessary to determine the County's rights and the Contractor's obligations under the Contract or to ascertain facts relative to any claim against the Contractor which may result in a charge against the County;
- e) To determine any difference in cost occasioned by a permissible substitution; and/or
- f) For any other reason in the County's sole judgment.

**11.2** Contractor shall provide the County (or its representatives), reasonable access during working hours to the Contractor's books and records. The County's audit rights shall be liberally construed in the County's favor.

**11.3** The Contractor, from the effective date of final payment or termination hereunder, shall preserve and make available to the County for a period of three (3) years thereafter, at all reasonable times at the office of the Contractor (but without any charge to the County), all its books, records, documents, photographs, micro-photographs, and other evidence bearing on the costs and expenses of the Contractor under this Contract and relating to the Work hereunder.

**11.4** The County will make all payments required of it under this Contract subject to audit, under circumstances stated above, which audit may be performed at the County's option, either during the Contract time period or during the record retention time period. Regardless of authorization, approval or acceptance, signatures or letters which are given by the County and are part of the County's control systems or are requested by the Contractor, the payments made under this Contract shall not constitute a waiver or agreement by the County that it accepts as correct the billings, invoices or other charges on which the payments are based. If the County's audit produces a claim against the Contractor, the County may pursue all its legal remedies even though it has made all or part of the payments required by this Contract.

**11.5** If any audit by the County or its representative discloses an underpayment by the County pursuant to the terms of the Contract Documents, the County shall have the duty to pay any amount found by the audit to be owed to the Contractor. If such audit discloses an overpayment, the Contractor shall have the obligation to reimburse the County for the amount of the overpayment. The County's right to claim reimbursement from the Contractor of any

overpayment shall not be terminated or waived until three years after the completion of the County's audit or upon the termination of audit rights under Subsection (f) of this Section, whichever date is later. The obligation of the Contractor to make reimbursements hereunder shall not terminate except as provided by law.

**11.6** The County's right to audit and the preservation of records shall terminate at the end of three (3) years after the date final payment is made or termination of the Contract. The Contractor shall include this "Right to Audit and Preservation of Records" clause in all subcontracts issued by it and it shall require the same to be inserted by all lower tier Subcontractors in their subcontracts, for any portion of the work. Should Contractor fail to include this clause in any such contract or lower tier contract, or otherwise fail to insure the County's rights hereunder, Contractor shall be liable to the County for all costs, expenses and attorney's fees which the County may have to incur obtaining or attempting to obtain an audit or inspection of or the restoration of records which otherwise would have been available to the County from said persons under this clause. Such audit may be conducted by the County or its authorized representative.

**12. RECORDS OF HOURS WORKED AND WAGES PAID**

Contractor shall maintain records of the hours and wages of its employees, and such records shall be open at all times for inspection by the County, the Division of Labor Statistics, or Law Enforcement in accordance with Section 1812 and 1776 of the California Labor Code.

**13. COUNTY'S RIGHT TO ADD OR DELETE DEVICES/LOCATIONS**

The County reserves the right to make additions, deletions, revisions and/or otherwise modify the Scope of Work, including additions and deletions of locations and devices serviced by the Contractor. If a device is added to the contract for planned maintenance, then the Contractor shall quote a fixed fee for planned maintenance for the device. Any changes to the contract shall be initiated via the County's Contract Amendment process.

**14. GOVERNING LAW AND VENUE**

The parties enter into this Agreement in the County of Placer, California and agree to comply with all applicable laws and regulations therein. The laws of the State of California shall govern its interpretation and effect. For litigation purposes, the parties agree that the proper venue for any dispute related to the Agreement shall be the Placer County Superior Court or the United States District Court, Eastern

The following provisions are hereby made a part of this Invitation for Bids ("bid") by reference and attachment to the Invitation for Bids document. **Any contract award made as the result of this bid shall be governed by these General Terms and Conditions.** By submission of a bid, bidder does agree if the bid is accepted within 90 calendar days from the date of opening, to furnish the product(s) and/or service(s) pursuant to these conditions. In the event of a contract award pursuant to this bid, performance by the successful bidder of any or all of the services, or delivery of any or all of the products defined herein, shall constitute acceptance of all terms, conditions and requirements of the resulting agreement.

**WARNING:** It is the bidder's responsibility to monitor the County's website for possible addenda to this bid to inform him/herself of the most current specifications, terms, and conditions (see also Section 4 below), and to submit his/her bid in accordance with the original bid requirements and all addenda. Failure of bidder to obtain this information shall not relieve him/her of the requirements contained therein. 4. NON-COLLUSION. The bidder certifies that his bid is made without any previous understanding, agreement or connection with any person, firm or corporation making a bid for the same project and is in all respects fair, without outside control, collusion, fraud or otherwise illegal action.

5. CONFLICT OF INTEREST. Bidder states that no County officer or employee, nor any business entity in which they have an interest, has an interest in the bid awarded or has been employed or retained to solicit or aid in the procuring of the resulting contract, nor will any such person be employed in the performance of such contract.

6. AWARD. The contract may be awarded to the lowest responsible and responsive bidder complying with the provisions of the Invitation for Bid. If bids are based on equivalent products, the bids must: 1) Indicate on the bid form the alternate manufacturer's name and catalog number; 2) Include complete descriptive literature and/or specifications; 3) Include proof that the proposed equivalent shall meet the specifications. The County reserves the right to be the sole judge of what is equal and acceptable. If bidder fails to name a substitute, goods identical to the bid standard must be furnished.

10. **INSURANCE AND INDEMNIFICATION.** The awarded bidder may be required to provide proof of liability, automobile, and/or workers compensation insurance. If required, the minimum coverage requirements will be identified in the bidding documents. All costs of complying with the insurance requirements shall be included in your pricing. The selected firm shall provide complete and valid insurance certificates within ten (10) days of the County's written request. Failure to provide the documents within the time stated may result in the rejection of the bid response and/or cancellation of the resulting contract or purchase order.

Unless indemnification requirements are stated otherwise in this solicitation, said requirements shall be as follows: The awarded bidder ("Contractor") hereby agrees to protect, defend, indemnify, and hold Placer County free and harmless from any and all losses, claims, liens, demands, and causes of action of every kind and character including, but not limited to the amounts of judgments, penalties, interest, court costs, legal fees, and all other expenses incurred by Placer County arising in favor of any party, including claims, liens, debts, personal injuries, death, or damages to property (including employees or property of the County) and without limitation by enumeration, all other claims or demands of every character occurring or any way incident to, in connection with or arising directly or indirectly out of, the contract or agreement. The Contractor agrees to investigate, handle, respond to, provide defense for, and defend any such claims, demand, or suit at the sole expense of the Contractor. Contractor also agrees to bear all other costs and expenses related thereto, even if the claim or claims alleged are groundless, false, or fraudulent. This provision is not intended to create any cause of action in favor of any third party against Contractor or the County or to enlarge in any way the Contractor's liability but is intended solely to provide for indemnification of Placer County from liability for damages or injuries to third persons or property arising from Contractor's performance pursuant to the resulting contract or agreement.

11. **FORCE MAJEURE.** If an emergency or natural disaster causes delay or interferes with the use or delivery of the products/services described in this bid, deliveries may be suspended as long as needed to remove the cause or repair the damage. An emergency or natural disaster includes fire, flood, blizzard, strike, accident, consequences of foreign or domestic war, or any other cause beyond the control of the parties. The County reserves the right to acquire from other sources any products/services during any suspension of delivery.

12. **TAXES.** Placer County is exempt from Federal Excise Tax; an exemption certificate will be furnished upon request. Placer County is not exempt from California State sales/use taxes. All applicable State sales/use taxes will be added to the purchase order.

13. **DELIVERY.** All prices bid must be FOB Destination, unloaded inside and assembled unless otherwise indicated.

14. **FIXED CONTRACT QUANTITIES.** Purchase order(s) for full quantities will be issued to successful bidder(s) after notification of award and receipt of all required documents.

15. **OPEN-END CONTRACT.** No guarantee is expressed or implied as to the total quantity of commodities/services to be purchased under any open-end contract. Estimated quantities/bid ratio or discounts from manufacturer's list price may be used for bid comparison. The County reserves the right to: issue purchase orders as and when required; or issue a contract for individual agencies or multiple County agencies; or any combination of the preceding. No delivery shall be made without a written order by the County, unless otherwise specifically provided for in the contract. If in a subsequent year the vendor offers to supply his goods and service for the same bid price, or in the event the supplier is willing to negotiate to the satisfaction of Placer County any justifiable price increase prior to the succeeding year's contract renewal and if the service provided by the supplier was to the satisfaction of the County, the County of Placer reserves the right to extend the period of the resulting contract on a year-to-year basis. Alternatively, the bid solicitation may set forth specific renewal terms. Bidder certifies that prices charged to the County for non-listed commodities or no-fixed price items are equal to or less than those charged the bidder's most favored customer for comparable quantities under similar terms and conditions.

16. **TERMINATION OF CONTRACT.** In the event of a material breach of the contractual obligations by the Contractor, the County may terminate the contract. At its sole discretion, the County may give the contractor an opportunity to cure the breach or to explain how the breach will be cured. The actual cure must be completed within no more than 10 working days from notification, or at minimum the contractor must provide the county within 10 working days from notification a written plan detailing how the contractor intends to cure the breach. If the contractor fails to cure the breach or if circumstances demand immediate action, the County will issue a notice of immediate termination. Supplier Contracts may be terminated by the County without cause upon 30 calendar days' written notice.

17. **NON-APPROPRIATION.** In the event that sufficient funds are not appropriated and budgeted for the payment of goods or services described herein, the agreement shall immediately terminate on the last day of the fiscal period for which appropriations were received or other amounts were available to pay the amounts due under the agreement, without penalty or expense to the County of any kind whatsoever, except that the County will be liable for payment of any unpaid invoices for goods or services which were delivered prior to the end of the last fiscal period for which appropriations were made.

18. **RIGHTS AND REMEDIES OF COUNTY FOR DEFAULT.** If any item or service furnished by the vendor fails to conform to bid specifications, or to the sample submitted by the vendor with his bid (if any), or if the vendor fails to deliver the items or perform any services required by the contract in the time and manner prescribed, the County may reject the products and/or services provided. Upon rejection, the vendor must promptly reclaim and remove any rejected items without expense to the County, and shall immediately replace all such rejected items with others conforming to such specifications or samples, and/or correct the service deficiency. If the vendor fails to do so, the County has the right to purchase in the open market a corresponding quantity of the rejected items, or have another firm provide the required service, and to deduct from any monies due the vendor the difference between the price named in the contract or purchase order and the actual cost to the County. If the vendor breaches the contract or purchase order, any loss or damage sustained by the County in procuring items which the vendor therein agreed to supply shall be borne and paid for by the vendor. The rights and remedies of the County identified above are in addition to any other rights and remedies provided by law or under the contract. In any legal proceeding brought to enforce the terms of the herein agreement, the prevailing party shall be entitled to an award of reasonable attorney's fees and costs incurred as a result of enforcing the terms of this agreement.

19. **LOCAL VENDOR PREFERENCE.** A local preference credit of 5.0% for Placer County businesses will be permitted when evaluating bids for supplies, equipment, materials and services that are not part of a public project. Bidders claiming local vendor preference must submit an Affidavit of Eligibility with their bid, unless an authorized affidavit is already on file with Placer County Procurement. 20. **INVOICES AND PAYMENT TERMS.** Invoices are to be mailed to the County department specified on the resulting purchase order or contract. All invoices must include the purchase order or contract number. Failure to comply will result in delayed payments. The County will make payment on a Net 30-day basis unless a cash discount is allowed for payment within the time period specified by vendor. The payment term shall begin on the date the merchandise is inspected, delivered and accepted by the County, or on the date a correct invoice is received in the office specified in the order, whichever is later. Prompt payment discounts shall be considered earned if payment is postmarked or personally delivered within the prescribed term. For the purposes of this section, the beginning date described above shall be considered day zero for the purposes of counting days in the prescribed term. For the purposes of bid evaluation, the County will only consider discount periods of ten (10) days or more. **LATE FEES:** In accordance with Section 926.10 of the California Government Code, Placer County may pay interest at not more than the rate of 6% per annum on invoices which are unpaid 61 or more days beyond the "beginning date" or "day zero" as defined above. In cases where this policy may conflict with other terms provided by the supplier, this provision shall prevail.

21. **LEGAL REQUIREMENTS.** Federal, State, County and local ordinances, rules and regulations, and policies shall govern development, submittal and evaluation

of bids and disputes about bids. Lack of knowledge by any bidder about applicable law is not a defense.

22. **ASSIGNMENT.** Any contract awarded shall not be assignable by the vendor without the express written approval of the County, and shall not become an asset in any bankruptcy, receivership or guardianship proceedings.

23. **OTHER AGENCIES.** The successful vendor shall agree to extend Placer County contract prices and terms to other governmental agencies. Any contract resulting from this requirement shall be executed by the successful vendor and the other agency. Placer County will not be a party to "other agency" contracts.

24. **PROTEST AND APPEAL PROCESS.** Any actual or prospective bidder or contractor who is aggrieved in connection with the solicitation or award of a contract may protest to the Director of Administrative Services in the manner prescribed by Section 6.0 of the Placer County Procurement Policy. The protest shall be submitted in writing to the Director of Administrative Services within five (5) County business days after such aggrieved person or company knows or should have known of the facts giving rise thereto.

25. **RECYCLED PRODUCT PREFERENCE.** A preference of 10% will be given to bids for products meeting the definition of recycled product cited in Public Contract Code Sections 22150 - 22154. In order to be granted this preference bidder shall provide statements and/or documentation as supporting evidence that the product(s) meets the definition.

26. **PATENT INFRINGEMENT.** Supplier shall indemnify and hold harmless County, its agents and employees, against and from any and all actions, suits, liabilities, prosecutions, penalties, settlements, losses, damages, costs, charges, attorney's fees, and all other expenses which may arise directly or indirectly from any claim that any of the products supplied by supplier infringes any patent, copyright, trade secret, or other property right.

27. **VENDOR FINANCIAL STABILITY.** If a vendor is currently involved in an ongoing bankruptcy as a debtor, or in a reorganization, liquidation, or dissolution proceeding, or if a trustee or receiver has been appointed over all or a substantial portion of the property of the vendor under federal bankruptcy law or any state insolvency law, the vendor must provide the County with that information as part of its bid/proposal. In accordance with Section 3.12(g) of the Placer County Purchasing Policy Manual and paragraph 8.e. of this document, the County may use information regarding a bidder's financial responsibility when making an award determination.

The County reserves the right to take any action available if it discovers a failure to provide such information to the County, including but not limited to, a determination that the vendor should be declared non-responsible and/or non-responsive, and suspension or debarment of the vendor, in accordance with the processes defined in the Placer County Purchasing Policy Manual.

By submitting a bid/proposal in response to this solicitation, the vendor agrees that if, during the term of any contract it has with the County, it becomes involved as a debtor in a bankruptcy proceeding, or becomes involved in a reorganization, liquidation, or dissolution proceeding, or if a trustee or receiver has been appointed over all or a substantial portion of the property of the vendor under federal bankruptcy law or any state insolvency law, the vendor will immediately provide the County with a written notice to that effect and that it will provide the County any relevant information requested in order for the County to determine whether the vendor has the financial ability to meet its obligations to the County.

28. **GENERAL HEALTH MEASURES AND CONDUCT.** The awarded firm(s) (Contractor) shall be solely responsible for ensuring that the Contractor's employees or sub-contractors are physically capable of performing the services described herein on County premises. The Contractor shall take all necessary measures to ensure that the Contractor's employees and sub-contractors receive sufficient training regarding contagious and infectious diseases and preventative measures to be taken within the workplace to protect the Contractor's employees and sub-contractors from exposure to or exposing others (including but not limited to County personnel and the public) to contagious and infectious diseases. Should the County or the Contractor observe any of their employees or sub-contractors exhibiting symptoms of a contagious and/or infectious disease (including but not limited to COVID-19) either prior to or during the performance of services on County premises, the Contractor shall immediately take measures to minimize or prevent exposure to County employees and/or the public consistent with government guidance and best practices. Such removal shall not be considered a basis for employee's claim for compensation or damages against the County, or any of its officers or agents. The employee shall not return to work on County premises until Contractor determines that the situation is resolved.

29. **CONFIDENTIAL OR PROPRIETARY INFORMATION / PUBLIC RECORDS.** Each bid will be publicly opened and made available for public inspection in accordance with the State of California Government Code (Title 1, Division 7, Chapter 3.5 – Inspection of Public Records), also referred to as the "Public Records Act". If the bidder includes confidential or proprietary information in its bid, the information must be clearly identified as such. Bidders are cautioned that such claims are subject to legal review in accordance with the mandates of the Public Records Act and may be challenged or rejected.
