OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE RENEWAL PERSONAL SERVICES CONTRACT WITH JOSEPH MARZANO, M.D. FOR PSYCHIATRIC SERVICES

WHEREAS, per Resolution 17-297, the Board approved the renewal Contract with Joseph Marzano, M.D. to provide direct clinical psychiatric services including the examination, diagnosis and treatment of adult clients receiving County Mental Health, Drug and/or Alcohol Services; and

WHEREAS, the Contractor shall determine therapeutic and medication needs, develop treatment plans, participate in case conferences, consult with clinical staff regarding support services, placement and treatment options, prescribe and administer medications and provide conservatorship evaluations as needed by the County; and

WHEREAS, the parties desire to amend their agreement to: increase the maximum contract price; extend the contract termination date; and revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 1 to the Personal Services Contract by and between the County and Joseph Marzano, M.D. pertaining to the provision of direct clinical and other psychiatric services for adult clients of Nevada County Behavioral Health Department, which increases the Maximum Contract Price from \$30,000 to \$60,000 (an increase of \$30,000); extends the Contract Termination Date from December 31, 2017 to June 30, 2018; and revises Exhibit "B" Schedule of Charges and Payments, to reflect the increase in the maximum contract price, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment No. 1 on behalf of the County of Nevada.

**AMENDMENT #1 TO THE CONTRACT WITH
JOSEPH MARZANO, M.D., FOR PSYCHIATRIC SERVICES**

THIS AMENDMENT is dated this 14th day of November, 2017 by and between JOSEPH MARZANO, M.D., hereinafter referred to as "Contractor," and COUNTY OF NEVADA, hereinafter referred to as "County." Said Amendment will amend the prior Agreement between the parties entitled Personal Services Contract, as approved per Resolution No. 17-287.

WHEREAS, the Contractor provides direct clinical and other psychiatric services including the examination, diagnosis, and treatment of adult clients receiving County Mental Health, Drug and/or Alcohol Services; and

WHEREAS, the parties desire to amend their Agreement to: 1) increase the Maximum Contract Price from \$30,000 to \$60,000 (an increase of \$30,000); 2) extend the Contract Termination Date from December 31, 2017 to June 30, 2018; 3) revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, the parties hereto agree as follows:

1. That Amendment #1 shall be effective as of November 14, 2017.
2. That Section (§2) Maximum Contract Price, shall be changed to the following: \$60,000.
3. That Section (§3) Contract Termination Date, shall be changed to the following: 06/30/2018.
4. That Exhibit "B", "Schedule of Charges and Payments", shall be revised to the amended Exhibit "B" as attached hereto and incorporated herein.
5. That in all other respects the prior agreement of the parties shall remain in full force and effect.

EXHIBIT "B"
SCHEDULE OF CHARGES AND PAYMENTS
Joseph Marzano, M.D./Psychiatrist

The maximum contract price for all services rendered to County in accordance with Exhibit "A", shall not exceed \$60,000 for the contract term. County shall reimburse Contractor at a rate of \$160.00/per hour.

In consideration of services provided by Contractor under this Agreement, County shall provide general liability insurance and professional liability (malpractice) insurance, for which coverage shall be specifically limited to liabilities from services provided by Contractor under this Agreement.

County and Contractor recognize and acknowledge that Contractor is an independent contractor and sole proprietor in providing services under the terms of this agreement and as such, shall not be covered under the County's Workers' Compensation policy.

Contractor shall submit invoices once a month for services provided. Contractor shall provide on his monthly invoice a breakdown listing the date and number of hours that are being billed. The Contractor shall not exceed the maximum of one (1) hour per week for therapeutic phone consultation services. Contractor shall specify on invoice when billing for phone consultation hours.
