



# RESOLUTION No. 19-161

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND JAMES WHITE CONSTRUCTION, INCREASING THE CONTRACT AMOUNT BY \$35,000 FOR A MAXIMUM CONTRACT PRICE OF \$60,000 AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, on December 3, 2018, the Purchasing Agent executed a Personal Services Contract PESM3699 with James White Construction for snow removal and sanding services at Nevada County Facilities in Truckee in the amount of \$25,000; and

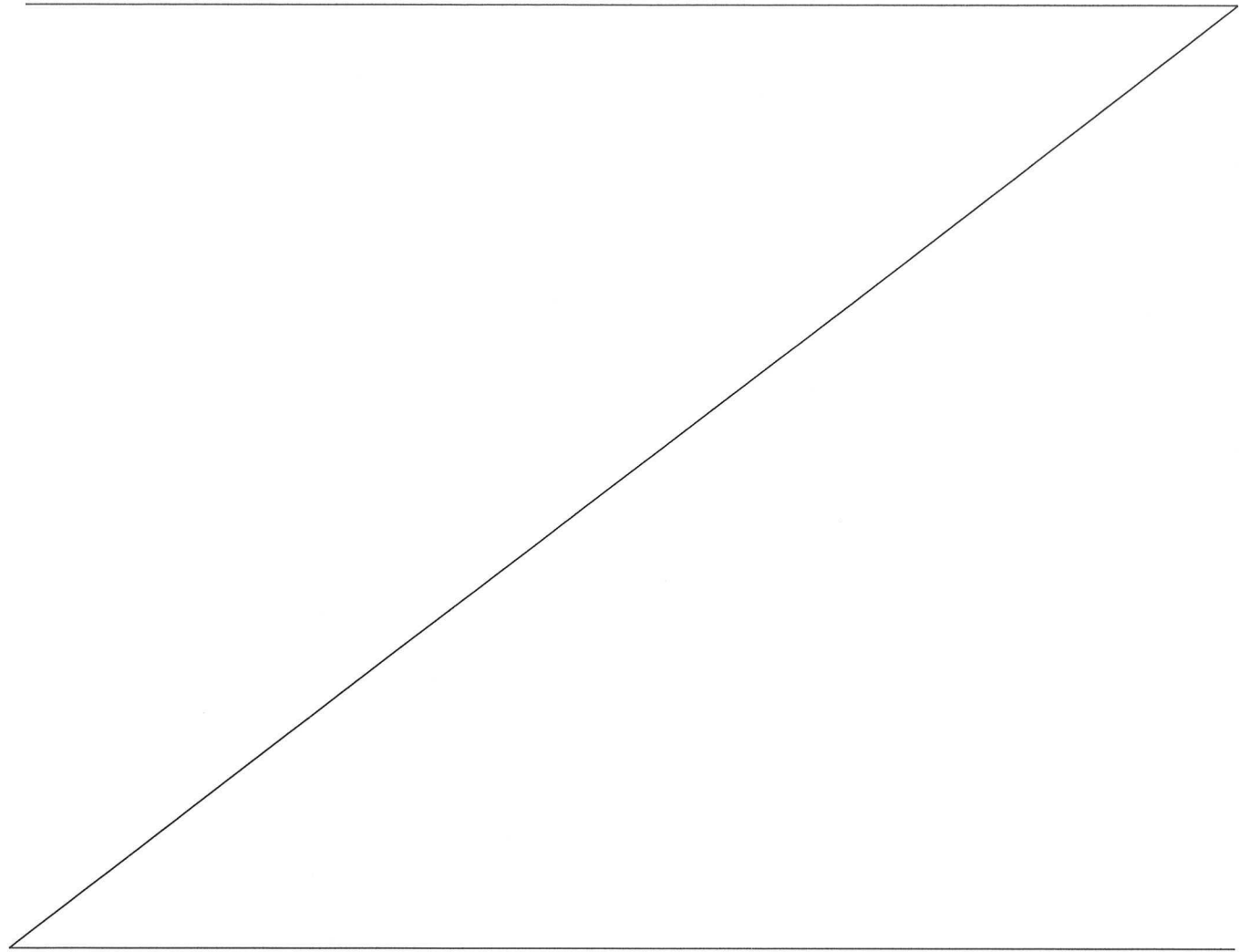
WHEREAS, greater than anticipated inclement weather has increased snow levels in the Truckee area this winter and additional funding is necessary to pay for these services; and

WHEREAS, funding for these additional services will be paid out of the Fiscal Year 2018/19 Facilities Management and Library budgets and a budget amendment is not required.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

1. The Board approves and the Board Chair is authorized to execute Amendment No. 1 to the Personal Services Contract by and between the County of Nevada and James White Construction for snow removal and sanding services in Truckee.
2. The Maximum Contract Price of \$25,000 is increased by \$35,000 to \$60,000.
3. In all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
4. The Auditor-Controller is directed to encumber the contract in the amount of \$30,000 for Facilities Management and \$5,000 for the Library plus any balance remaining in encumbrance PESM3699, against the Fiscal Year 2018/2019 Facilities Management and Library budgets and to close encumbrance PESM3699.

**AMENDMENT NO. 1 TO CONTRACT PESL3468  
WITH JAMES WHITE CONSTRUCTION**

**THIS AMENDMENT** is executed this 23rd day of April, 2019 by and between James White Construction, (herein "Contractor") and COUNTY OF NEVADA (herein "County"). Said Amendment will amend the prior agreement between the parties entitled "Snow removal and sanding at Nevada County Facilities in Truckee" executed on December 3, 2018.

**WHEREAS**, the contract was executed between the County and Contractor to provide snow removal and sanding services at Truckee facilities for the period November 1, 2018 through June 30, 2019; and

**WHEREAS**, the parties desire to amend their agreement to allow for additional snow removal and sanding services in the amount of \$35,000.


**NOW THEREFORE**, the parties hereto agree as follows:

1. That this amendment shall be effective as of April 23, 2019.
2. That Section 2 is amended to increase the Maximum Contract Price by \$35,000 to \$60,000.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.




