SUBJECT: Award of Contract for Nevada County Striping 2015 (Phase 1 and Phase 2)
Contract No. 426622

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Funding is for FY 14/15 and FY 15/16 and impacts the Road Maintenance budget. Funding is provided by Measure F and no budget amendment is needed. There is no impact to the County's General Fund.

BACKGROUND:

On March 10, 2015, the Nevada County Board of Supervisors adopted Resolution No. 15-107 that approved the plans, specifications and cost estimate for the subject project and instructed the Clerk of the Board of Supervisors to advertise for bids. The bids were opened on April 9, 2015, at 3:00 p.m. and are listed below:

The bid documents specifically call for recent work experience by the Contractor or Subcontractor be listed on the "Experience" forms included in the bid documents or the bid will be disqualified. The work is specialized work that includes installing recessed thermoplastic striping and recessed markers.

Bidding documents state in several locations that work experience forms **must** be submitted with bid or the bid **will** be disqualified.

Award is recommended for the contract work to the second low bidder, Linear Options, Inc., at the bid price of \$263,420.90.

The amount to be encumbered for Phase 1 in FY 14/15 is \$121,045.00, which includes a 10 percent contingency. The amount to be encumbered for Phase 2 in FY 15/16 is \$168,717.90, which includes a 10% contingency. The total encumbrance for the project will be \$289,762.99.

Phase 1 is scheduled to begin in June of 2015, and be completed within 20 working days, as allowed for in the contract. Phase 2 is scheduled to begin in September of 2015, and be completed within 25 working days, as allowed for in the contract.
