OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN COUNTY OF NEVADA AND VICTOR COMMUNITY SUPPORT SERVICES TO MODIFY THE SCOPE OF WORK TO INCLUDE PROVISION OF STRENGTHS, OPPORTUNITITES AND RECIDIVISM REDUCTION PROGRAM SERVICES TO A MAXIMUM OF FIVE YOUTH AND THEIR FAMILIES AND INCREASE THE MAXIMUM AMOUNT OF THE CONTRACT TO \$146,024

WHEREAS, in 2015 the Probation Department was awarded a Mentally Ill Offender Crime Reduction (MIOCR) grant (Resolution 15-346); and

WHEREAS, MIOCR monies may be used to expand treatment services for youthful offenders suffering from mental illness; and

WHEREAS, the Chief Probation Officer desires to provide a mental health program of Strengths, Opportunities and Recidivism Reduction (SOARR) services; and

WHEREAS, on June 16, 2015, the County of Nevada entered into a personal services contract with Victor Community Support Services in the amount of \$116,024 (Resolution 15-268); and


WHEREAS, the parties now desire to amend the contract to amend the scope of work accordingly and increase the maximum amount of the contract by \$30,000.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, of the County of Nevada that Amendment No. 1 to the Personal Services Contract between the County of Nevada and Victor Community Support Services modifying the scope of work and increasing the maximum contract amount to \$146,024 be and hereby is approved, and the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 1 on behalf of the County of Nevada.

Amended SOARR services are funded by the State Mentally III Offender Crime Reduction grant Account apportionment for the contract term of July 1, 2015 through June 30, 2016.

Funds to be disbursed from 0101-20320-201-1000 / 521520 not to exceed the maximum contract amount of \$146,024.

BE IT FURTHER RESOLVED, that the Nevada County Board of Supervisors hereby directs the Auditor Controller to encumber additional \$30,000 for Fiscal Year 2015-2016.

AMENDMENT #1 TO PERSONAL SERVICES CONTRACT NO. BFS15268 WITH VICTOR COMMUNITY SUPPORT SERVICES

THIS AMENDMENT is executed this 22nd day of March 2016 by and between VICTOR COMMUNITY SUPPORT SERVICES(VCSS) and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled PROVIDE TRANSITIONAL, THERAPEUTIC AND CASE MANAGEMENT SERVICES FOR JUVENILE AND ADULT PROBATIONERS executed on June 16, 2015 by Resolution #15-268.

WHEREAS, the parties desire to amend their agreement to provide additional mental health services for youthful offenders and their families; and

WHEREAS, the parties desire to amend the contract amount from \$116,024 to \$146,024.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That this amendment shall be effective as of March 22, 2016.
- 2. That paragraph two (2) "Maximum Contract Price" shall be changed to \$146,024.
- 3. That the Schedule of Services, Exhibit "A" shall be amended by adding the following:

Upon referral and authorization from Nevada County Probation Department contractor shall provide the following services consistent with the Strengths, Opportunities and Recidivism Reduction Program (SOARR) to a maximum of 5 youth and their families:

A. Case Plan Development towards goals of reduced recidivism and higher quality life

Contractor will coordinate and schedule Youth and Family team meetings. Teams will consist of:

Youth and their Families VCSS Contracted Clinician Probation Officer Juvenile Hall Case Manager

Other team members may include:

VCSS Parent Partner
Rehabilitation Specialists
Teachers
Collaborative Court Representatives
Substance Abuse Counselors
Other Supports identified by the family

B. SOARR Program Intervention Services to promote youth and family achievement of wellness, skill building and sustainability of progress

Contractor will provide intervention services including:

CBT and TF-CBT
Pro-Social Group Opportunities
Mental Health Assessments
Mental Health Treatment including individual and family therapy
Evidence Based Substance Abuse Treatment
Facilitation of Individual and Family Skill building
Aggression Replacement Training (in collaboration with Probation partner contractors)

Moral Reconation Training
Parent Project Parenting Training
Parent training to build parenting skills, connect families with community resources and natural supports to build capacity and self-sufficiency.

C. Case Management:

- Intensive case management which includes referrals and linkages to community resources (ie drug treatment, mental health and social services, transitional housing, employment services, medication management and education)
- Coordination with the assigned Probation Officer
- A "warm handoff" to appropriate outside agencies and services (ensures the family meets someone at the agency who can engage them in needed services)
- Assessment, observation, behavioral interventions in schools and collaboration with school personnel
- Case Plan monitoring
- D. **Tracking and Reporting:** Monthly Progress reports for each participant youth will be produced monthly for Probation Department. Reports shall include:

- 4. That the Schedule of Charges and Payments, Exhibit "B" shall be amended by adding the following pertaining to clients receiving SOARR services:
- Fully loaded cost of clinician(s), mental health rehabilitation specialist(s) and parent partner(s) supervised by VCSS
- Clinical hours provided to Probation clients and families
- Services provided
- Identification of youth and family members served
 - 5. That in all other respects the prior agreements of the parties shall remain in full force and effect except as amended herein.
