

ORDINANCE No. 2535__

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

AN ORDINANCE RENUMBERING AND AMENDING, ALL SECTIONS OF THE NEVADA COUNTY ADMINISTRATIVE, GENERAL AND LAND USE CODES

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION I:

Findings and Declarations

- A. Pursuant to Article XI, section 7 of the California Constitution, the County of Nevada ("County") may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its residents.
- B. Amendments to these Codes are part of an on-going effort to recodify and reorganize provisions of the Nevada County Codes and the changes are intended to be entirely non substantive in effect. Language and punctuation changes are editorial in nature. All sections of the Administrative, General and Land Use Codes are combined and reordered in an effort to provide clarification and transparency for the governing codes of the County of Nevada.

SECTION II:

- 1. Articles I through VIII of the Administrative Code are hereby revised and amended to read as shown in "Exhibit A" attached hereto and incorporated by reference;
- 2. Articles I through X of the General Code are hereby revised and amended to read as shown in "Exhibit A" attached hereto and incorporated by reference;
- 3. Articles I through XVII of the Land Use Code are hereby revised and amended to read as shown in "Exhibit A" attached hereto and incorporated by reference;
- 4. Appendix of past Code Revisions.

SECTION III:

Severability. If any provision of these Chapters or the application thereof to any person or circumstance is held invalid, the remainder of these Chapters, including the application of such part or provision to other circumstances shall not be affected thereby and shall continue in full force and effect. To this end, provisions of these Chapters are severable. The Board of Supervisors hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase hereof irrespective of the fact that any one (1) or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be held unconstitutional, invalid or unenforceable.

SECTION IV:

This Ordinance shall be passed and adopted immediately after notice and a public hearing as required by statute, and shall take effect and be in force at the expiration of thirty (30) from and after its passage, and shall become operative on the 23rd day of May 2024, and before the expiration of fifteen (15) days after its passage a summary shall be published once, with the names of Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
