OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND ROBINSON ENTERPRISES INC. FOR LEACHATE TRANSPORTATION SERVICES FOR THE MCCOURTNEY ROAD CLOSED LANDFILL/TRANSFER STATION AND A BUDGET AMENDMENT (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on June 20, 2017, the Nevada County Board of Supervisors adopted Resolution No. 17-322 awarding a contract to Robinson Enterprises, Inc. for Leachate Transport Services at the McCourtney Road Closed Landfill on an “as needed” basis; and

WHEREAS, on June 19, 2018, the Nevada County Board of Supervisors adopted Resolution No. 18-277 renewing the contract from July 1, 2018 through June 30, 2019; and

WHEREAS, between January and March 2019, the facility received nearly 32 inches of rain, producing 3.1 million gallons of leachate, nearly twice the average amount of leachate for the period; and

WHEREAS, there is a continuing need for Leachate transport services at the McCourtney Road Closed Landfill; and

WHEREAS, the Department recommends amending the contract with Robinson Enterprises, Inc. for an additional \$100,000 for a total contract amount not to exceed \$450,000; and

WHEREAS, this amendment will be funded by the Fiscal Year 2018/19 Solid Waste Western budget account 4117-91001-705-1000/537500. A budget amendment is included.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves Contract Amendment No. 1 and authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the attached amendment between Nevada County and Robinson Enterprises Inc.
2. Approves increasing the maximum contract amount of \$350,000 to a not-to-exceed contract amount to \$450,000.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes the release of Solid Waste Western 4117 funds in the amount of \$100,000 and directs the Auditor-Controller to amend the Fiscal Year 2018/19 Solid Waste Western budget as follows:



**AMENDMENT NO. 1 TO CONTRACT
WITH ROBINSON ENTERPRISES, INC.**

THIS AMENDMENT is executed this 23rd day of April 2019, by and between Robinson Enterprises, Inc. and COUNTY OF NEVADA. Said Amendment will amend the prior agreement which was renewed between the parties entitled "Leachate Transport Services for the McCourtney Road Closed Landfill/Transfer Station Facility" and approved on June 19, 2018, per Resolution 18-277.

WHEREAS, the parties desire to amend the agreement to increase the maximum contract price.

NOW, THEREFORE, the parties hereto agree as follows:

1. That the Maximum Contract Price set forth in §2 is increased by \$100,000 for a total Contract Price of \$450,000.
